CALL TO ORDER

Board chair Ken Petersen called the regular meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:30 PM, Tuesday, April 24, 2018 at the Foundation's Monterey office.

Auditor's Report:

Steve McGowan introduced the audit team, Karen Semingson and Kim Said of Hutchinson and Youngblood, LLC. The audit team issued a clean, unmodified opinion for the 2017 audit. Karen summarized the audit process as:

- A clean unmodified opinion
- 3 adjustments were required:
 - o Adjustment to consolidate LLC
 - o 3 audit adjustments were prepared by the client after fieldwork began
 - Preliminary net income of \$46,403,280; adjusted net income of \$46,691,919
- Management Letter
 - There were no significant deficiencies or material weaknesses noted.
- Required Communications
 - o All required topics were discussed with management and Audit Committee
 - Adoption of ASU 2015-07 Fair Value Measurement as it relates to Level 3 investments
- Upcoming Audit Pronouncements
 - ASU 2016-14 Financial Statements of Not for Profits -replaces the traditional three classes of net assets with only two classes:
 - Those with donor-imposed restrictions and those without
 - Modifies and increases disclosure, including disclosures useful in assessing a nonprofit's liquidity position

Kim Said reviewed a chart comparing the last three years finances through growth in funds, grants awarded and other activities. She also looked at contributions by type and net investment income.

After the presentation by Karen Semington and Kim Said an executive session was called. Upon return the board recommended approval of the 2017 audit.

Motion: to approve the 2017 Audit Report as presented. Steve McGowan / Nolan Kennedy second. Motion carried unanimously.

Motion: to approve the Consent Agenda as presented. Ida Lopez Chan / Birt Johnson, Jr., second. Motion carried unanimously.

REPORT OF THE CHAIR – Ken Petersen

Ken Petersen reported on Women's Fund Luncheon held April 3, 2018 at the Hyatt Hotel. He thanked the board for attending and noted there were many positive comments from attendees. The event was well organized and the speakers were successful in delivering a strong message about the impact of the GHGH scholarship fund. The event netted \$95,000 and 61 GHGH scholarships were awarded shortly after the event.

Ken described the importance of 100% board giving and reminded each board member of their responsibility to make an annual financial contribution to the Foundation according to their personal means. It is mandatory we have 100% annual board giving in order to meet the grant requirements of some third-party funders.

Motion: to approve a resolution for 2018 for 100% financial participation by the CFMC board. Ken Wright / Bill Sharpe second. Motion carried unanimously.

de Guigne Real Estate Gift Update - Dan Baldwin and Attorney, Rick Kennifer

Dan Baldwin summarized the de Guigne real estate gift and how the process has gone to date. The CFMC has not yet received title to the property, but is proactively getting the Environmental Phase One, Historic Preservation and Opportunities and Constraints reports completed before the property goes on the market. Dan introduced attorney Rick Kennifer from Johnson, Fantl and Kennifer (JF&K) to update the committee on the transition of the distribution of the assets.

Rick reviewed the administration of the trust and estate of Mr. de Guigne and the ongoing negotiations with the trustee, Wells Fargo, and their legal counsel. Well Fargo submitted a proposal on March 16, 2018 which the legal team from JF&K found unacceptable. JF&K countered with an alternative proposal on March 23, 2018. Currently, JF&K is trying to set up a meeting with Wells Fargo counsel to clarify the actions they have taken, some of which may go against the trust instructions and could result in a significant tax implication. There is a probate court date set for July 18, 2018 to get the courts approval of the trustees proposed actions.

Rick reported there are potential delays in the transfer of the title and distribution of funds to the beneficiaries. The board discussed different approaches CFMC might take to the Wells Fargo counsel which will be considered at a meeting of the Real Estate committee next week.

INVESTMENT COMMITTEE – Steve McGowan

Steve McGowan reviewed the market value of the Long-Term fund, Medium-Term fund, and the ESG fund and overviews for the period ending 3/31/18. He summarized the year-to-date portfolio returns.

At the next Investment Committee meeting, on May 14, the committee will review asset allocations for Community Impact Investing.

COMMUNITY IMPACT INVESTING – Nolan Kennedy

Nolan Kennedy reported that the committee met to discuss next steps to allocate CFMC funds to invest in mission-related community projects while achieving a market rate return on the invested funds.

The committee has prepared three documents to recommend for approval: The Community Impact Investment Policy Statement, Addendum to CFMC's Investment Policy Statement and Community Impact Investment Committee Description. There was a mistake in the board packet and the current version of the documents revised and approved by the Community Impact Investment and Executive Committees was not in the packet. The board will be emailed the correct documents for a vote on April 25, 2018.

Board Action: April 25, 2018 Update:

Dan Baldwin sent the corrected Impact Investment Committee documents (April 2, 2018) that consist of: 1. Community Impact Investment Committee description, 2. Community Impact Policy Statement, and 3. an addendum to the Investment Policy Statement approved April 24, 2012 that allows for impact investments as a new asset allocation.

Board Action: April 27, 2018 Outcome: there was a majority vote of approval of the 1. Community Impact Investment Committee description, 2. Community Impact Policy Statement, and 3. the an addendum to the Investment Policy Statement approved April 24, 2012.

A copy of the corrected documents and vote results is attached to these minutes.

RESOURCE DEVELOPMENT – Call-in, Betsy Buchalter Adler

Betsy Buchalter Adler and Christine Dawson reported on the February and March Resource Development Summaries.

Christine Dawson distributed the 2018 Goals of the Philanthropic Services Department and Resource Development Committee.

TREASURER/FINANCE COMMITTEE – Dan Baldwin for Teri Belli

Dan Baldwin reviewed the notes to the financial statements for February and March 2018. He highlighted the line items where the impact of the Monterey County Gives campaign appears and explained the variances that occur in the first quarter of each year in the statements.

Motion: to approve the February 28, 2018 and Financial Statement. Jeff Eikenberry / Birt Johnson, Jr., second. Motion carried unanimously.

Motion: to approve the March 31, 2018 and Financial Statement. Bill Mitchell/ Birt Johnson, Jr., second. Motion carried unanimously.

GRANTS AND PROGRAMS – Birt Johnson, Jr.

Birt Johnson, Jr. requested approval of the February 1 - March 31, 2018 grants. There are 313 grants totaling \$6,289,416.

Motion: to approve 313 grants awarded from February 1 through March 31, 2018, totaling \$6,289,416.

Birt asked for approval of two grants over \$50,000 not on the agenda.

Laurel Lee-Alexander informed the board that the James Irvine Foundation has granted the CFMC \$1,250,000 for the "pilot regranting and capacity building program that will strengthen local nonprofit capacity and leadership in the areas of civic engagement and youth leadership as a means to expand economic and political opportunity for low-income residents in Salinas." An advisory committee has been created to help put the structure together for the program.

Community Foundation for Monterey County Addendum to Investment Policy Statement Approved April 24, 2012

Community Impact Investments

This addendum adds Community Impact Investments as an asset class in the Community Foundation for Monterey County's Investment Policy Statement. This addendum allows an allocation for Community Impact Investments within a range of 0 - 3%, and a target allocation of 2%. Decisions for placing Community Impact Investments will be overseen by the Community Impact Investment Committee. Returns will be shown on the monthly and quarterly reports produced by the CFMC's investment consultant, and reviewed by the CFMC's Investment Committee. While there is no standard benchmark, return expectations will be established by the CIIC. It is understood that the CIIC will monitor the social impact created by the investments.

Community Impact Investment Policy Statement

The Community Foundation for Monterey County (CFMC) seeks to utilize a portion of its investment portfolio in a manner that creates local impact. Local placements from the portfolio can support overall returns and create impacts consistent with the CFMC's mission (To inspire philanthropy and be a catalyst for sustaining communities throughout Monterey County.). The CFMC's program will be called Community Impact Investments. The investments must benefit Monterey County.

Impact investing is not new to philanthropy. Many private and community foundations are utilizing impact investments in various forms. Impact investments are not grants. They are placements of capital intended to bring market or near-market returns. Impact investments can range from the very simple (buying CDs at local credit unions) to the complex (investing directly in social enterprises). The CFMC seeks a middle ground of complexity by placing capital with intermediaries such as Community Development Financial Institutions (CDFIs) or like institutions. This strategy allows the CFMC to utilize expertise currently residing in the intermediaries. For example, rather than directly making loans to start-up farmers or women entrepreneurs, the CFMC's Community Impact Investment program will place capital with experienced organizations that work directly with the recipients of the funds. As the CFMC's Community Impact Investment program grows, it may choose to venture into more complex investments; should that occur, this policy statement will be amended to allow for such activity.

Capital for the CFMC's Community Impact Investments will come from the general portfolio. The CFMC's Investment Policy Statement (IPS) will be amended to allow for a new asset class: Community Impact Investments. The IPS will reflect an allocation range for Community Impact Investments of 0 - 3%, with a target allocation of 2%. Once approved, the CFMC may take up to three years to meet the target allocation.

No one investment will exceed 50% of the target allocation. Should the CFMC co-invest with another funder, it is only the CFMC's investment that counts toward the limit of 50% of the target allocation.

As Community Impact Investment placements are made, it will be important to consider the duration of each investment, allowing for flexibility to changing economic circumstances and the potential for liquidity.

It is understood that donor advisors may want to utilize their funds for Community Impact Investments.

The Community Impact Investment Committee will define what returns are deemed acceptable, considering the type of investment and how the investment is meeting a need in Monterey County. Investment return on the CFMC's impact investments will be monitored by the CFMC's Investment Committee, and returns will be included in the investment consultant's monthly and quarterly reports.

Community Impact Investment Committee Description

Oversight of the CFMC's Community Impact Investments will be performed by the Community Impact Investment Committee. The committee will be comprised 3 – 7 members. The chair must be a CFMC board member, and a majority of the committee will be comprised of CFMC board members. The chair will sit on the CFMC's Investment Committee. Staff will support the work of the committee.

The role of the Community Impact Investment Committee will be to:

- Develop a Community Impact Investment Policy Statement that can be recommended to the CFMC board of directors for approval;
- Develop and implement a process for identifying and placing investments;
- Develop and implement a process for determining the terms, conditions, and expected outcomes of each investment, including reporting by any intermediaries to which placements have been made;
- Develop and implement a process for monitoring the success of individual placements, not limited to investment return (e.g. alignment with the CFMC's mission). Investment impact can include reports on the number of jobs created, businesses started or housing units built
- Provide reports to the CFMC's Board of Directors and Investment Committee; and,
- Create a description of duties for the CFMC's finance department to utilize in working with and reporting on Community Impact Investments, including how impact investments interact with the CFMC's annual audit.

CALL TO ORDER – Birt Johnson, Jr. for Ken Petersen

Birt Johnson, Jr. called the regular meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:33 on May 22, 2018 at the Foundation's Monterey office.

APPROVAL OF MINUTES

Motion: to approve the March 27, 2018 minutes: Teri Belli / Betsy Buchalter Adler second. Motion carried unanimously.

de Guigne Real Estate Update

Birt Johnson introduced attorney Rick Kennifer from Johnson, Fantl and Kennifer (JF&K) to update the committee on the Charles de Guigne real estate gift.

Rick Kennifer passed out the edited version of the proposal submitted to Wells Fargo on March 23, 2018. The memo will be presented on May 25, 2018, to the Wells Fargo legal counsel to discuss and finalize the proposed plan. There are 4 items to finalize:

- 1) Wells Fargo will "immediately" transfer title to the Pebble Beach property to the Community Foundation.
- 2) The Community Foundation will "immediately" transfer to Wells Fargo sufficient funds to enable Wells Fargo to pay all of the specific beneficiaries in full. Upon receipt of those funds (in the amount of \$4,155,104), Wells Fargo will immediately pay all of the remaining specific bequests to all beneficiaries.
- 3) Assuming the Monterey County Probate Court rules as expected on July 18, 2018, and admits Charles' Will to probate, Wells Fargo will "immediately" thereafter transfer to the Community Foundation the sum of \$2,100,000, or the "net distributable assets" from the Generation Skipping Trust (GST), retaining a small reserve (\$26,565).
- 4) For future discussion/legal action: Wells Fargo will retain, for an undetermined period of time, a reserve in the amount of \$1,000,000 in the "2009 Trust" accounts, plus an additional amount of \$200,000 as a reserve for future attorneys' fees, plus \$240,000 for property tax and property maintenance (related to the Pebble Beach property), plus other incidental amounts in the approximate amount of \$45,000.

Rick and the Executive Committee discussed the details of the edited proposal at length and agreed that the proposal from JF&K is in the best interest of CFMC. The Committee agreed to authorize CFMC to advance sufficient funds, not to exceed \$4,200.000 to enable Wells Fargo to pay all the specific beneficiaries in full, contingent on the immediate transfer of title to the property and remaining assets to the CFMC.

Motion: to approve Community Foundation for Monterey County advance up to \$4.2 million to Wells Fargo Bank for the payment of all beneficiaries as stated in the Charles de Guigne Trust. The advance is contingent upon transfer of title to the Community Foundation for Monterey County of 3200 17 Mile Drive and a satisfactory agreement from Wells Fargo on the expedient transfer of assets from the de Guigne Generation Skipping Trust after the July 18, 2018 court hearing.

Ken Petersen / Betsy Buchalter Adler second. Motion passed unanimously.

REPORT OF THE CHAIR - Birt Johnson, Jr. for Ken Petersen

Birt Johnson reviewed the Distinguished Trustee process and list of recipients. The committee discussed the list, and at the end of the discussion the committee agreed on the first and second choices to recommend to the board.

Motion: to recommend to the full board at the June 26, 2018 meeting, to honor Leon and Silva Panetta or Lydia Villareal as the 2018 Distinguished Trustee at the 2018 Celebration of Philanthropy.

Teri Belli / Betsy Buchalter Adler second. Motion carried unanimously.

INVESTMENT COMMITTEE – Dan Baldwin for Steve McGowan

Dan Baldwin reported the Investment Committee discussed Community Impact Investing (CII) at the May 14 meeting.

The committee discussed the asset allocation range to be used for the CII project. The committee agreed on a safer approach of 0-3% allocation range instead of the proposed 0-5%.

Motion: To e recommend a 0-3% asset allocation range for Community Impact Investing and forward the recommendation for a vote to the full board at the June 26, 2018 meeting. Teri Belli / Ken Petersen second. Motion carried unanimously.

RESOURCE DEVELOPMENT COMMITTEE - Betsy Buchalter Adler

Christine Dawson highlighted the activities in the first quarter. She described the upcoming CPE forum and Professional Advisory Council meeting coming up in June.

The CFMC received the first fund which applies the Donor Recommended Investment Management (DRIM) policy for \$3,000,000.

TREASURERS REPORT-Teri Belli

Teri Belli reported the April 30, 2018 financials will be approved at the June board meeting.

GRANTS AND PROGRAMS COMMITTEE – Birt Johnson, Jr.

Birt Johnson reported there are five grants over \$50,000 for approval. **Donor Advised of \$50,000 or more:**

Motion: to approve the Katherine Curtis Springer Fund grant for up to \$77,250 to the Salinas Valley Memorial Hospital Foundation.

Real Estate Committee Update

Dan reported on the outcome of the completed Environmental Phase One, Historic Preservation and Opportunities and Constraints reports for the Charles de Guigne property. CFMC is still waiting on results to be finalized by Subtronics Company on the existence of underground storage tanks.

The Real Estate Committee is discussing the purchase of water credits with Pebble Beach Company which will allow the property to be split into two lots. Once the title has been transferred from Wells Fargo to the CFMC, the committee will move forward with plans to market the property for sale.

Community Foundations throughout the state will provide leadership and facilitation with the California Census campaign. The CFMC will co-host an information session May 31 in Salinas. CFMC is committed to a leadership position until the census is complete.

The regular meeting of the Investment Committee (IC) of the Community Foundation for Monterey County was called to order by Steve McGowan at 3:00 PM on May 14, 2018.

<u>Minutes</u>

On a motion by Ken Petersen, seconded by Teri Belli, the February 12, 2018 minutes were approved as written.

Community Impact Investing

Dan Baldwin updated the committee on the progress by the Community Impact Investment Committee (CII). Dan reviewed the types of investments, the roles of the IC and CII and the CII policy statement. There was a discussion by the committee on the investment returns (rate of return and social impact), reporting by Verus and their fiduciary responsibility. At the conclusion of the discussion on a motion by Bill Sharpe, seconded by Loren Steck, the voting members of the committee approved the amended Investment Policy Statement, but with a CII range of 0-3% versus 0-5%).

Donor Recommended Investment Manager Policy

Dan then reviewed the Donor Recommended Investment Manager Policy (DRIM) that was approved by the board in August 2013. He then stated that the foundation was in the process of establishing their first DRIM. There was a discussion by the committee regarding the policy. Anne Westreich provided a sample of how the DRIM's investment returns would be reported to the foundation. It was noted that the DRIM was being established by a Professional Investment Manager with 32 years of experience, and they would not be charging advisory fees. After discussion on a motion by Ken Petersen, seconded by Teri Belli, the voting members of the committee approved two policy exceptions for the Neumeier Taylor Foundation Fund DRIM (#1 - Donor must represent that the DRIM is not a related party and #2 – Total fee calculation - advisory fees).

<u>Verus</u>

Anne Westreich reviewed the first quarter 2018 investment results.

The market value of the Total Fund portfolio at 3/31/2018 was \$187,772,416. The YTD returns were -0.2% compared to the policy benchmark of -0.6%.

The market value of the Medium-Term portfolio at 3/31/2018 was \$4,658,784. The YTD returns were -0.6% compared to the policy benchmark of -1.1%.

The market value of the ESG portfolio at 3/31/2018 was \$2,986,789. The YTD returns were -0.6% compared to the policy benchmark of -1.1%.

Anne then reviewed the proposed changes to the Investment Policy Statement. She made recommendations on changing several benchmarks for the Medium & Long Term Performance Objectives. There was a discussion and the committee asked that the CII benchmark be changed from No Standard Benchmark to TBD by the CII Committee. Anne then reviewed the current Target Asset Allocation. The committee discussed the proposed changes and questioned the reason behind changing the Target Allocations versus rebalancing to current targets. After discussion on a motion by Bill Sharpe, seconded by Loren Steck, the voting members of the committee agreed to maintain status quo until the committee had worked through their questions on the Target Asset Allocation and rebalancing the portfolio.

Grants and Programs Committee Minutes of the May 24, 2018 Meeting

Call to Order: The regular meeting of the Grants and Programs Committee of the Community Foundation for Monterey County (CFMC) was called to order at 9:00 AM by Birt Johnson at the CFMC's Salinas office. Birt reviewed the 2018 meeting schedule and committee composition.

Approval of the February 7, 2018 minutes: Motion: Ida Lopez Chan/second: Ken Wright; motion carried.

Updates:

1. Neighborhood Grants Program (NGP)

Erika Matadamas presented an update of the program, including results of the program changes made for the 2018 cycle. Highlights include:

- Grant applicants overwhelmingly prefer to have individual meetings or calls instead of the Applicant Assemblies.
- Grantees expressed appreciation at the expedited grant application and approval process, including the discontinuation of the Applicant Assemblies. The discontinuation of the Awards Ceremony was also welcomed due to inconvenience of attending the event and waiting for the event to receive the grant check.
- Ken Wright, Board liaison participated in the applicant site visits and worked with Erika on determining recommendations for grants. He agreed the changes have improved the program changes and suggested including a Board member as a liaison for the program.
- The G&P team plans to continue program enhancements for future grant cycles.
- 2. Community Impact (Spring Cycle)

Janet Shing, Director of Grantmaking, gave an update on the 2018 Spring Community Impact Grants program.

- CFMC received a total of 82 applications this spring (43 Children & Youth abd 39 Health & Human Services), similar to the 83-86 received in recent years.
- Earlier this month, Dan approved 10 Small CI grants \$12,000 or less (7 CY, 3 HHS).
- Yesterday, sub-committee #2 recommended 24 grants (with an average size of \$24,000) and six denials. Sub-committee #1 meets later today.
- 3. James Irvine Foundation Re-granting Project

Laurel Lee-Alexander shared a presentation of the recently announced grant to the CFMC from The James Irvine Foundation. The grant is for \$1.25 million over 18 months to support resident engagement and leadership development in Salinas through a pilot regranting partnership and is being led by Laurel and Kaki Rusmore, Director of the CNE. \$1M will be allocated to expand economic and political opportunity for low-income residents in Salinas; specifically to strengthen local nonprofit capacity and leadership in the areas of civic engagement and youth leadership. The first step is to identify effective strategies and gaps in community-led efforts in Salinas through a community assessment. \$250K will be allocated for program/operating support for the project. The CFMC is currently in Phase I: community assessment and is working with an advisory committee of local funders, nonprofits engaged in community development in Salinas, the City of Salinas and others.

In the absence of committee chair Steve McGowan, Dan Baldwin called the meeting to order at 4:10 pm. Dan reviewed the Governance Committee duties. He then outlined the year's meeting schedule, and what generally occurs at each meeting. The committee then reviewed what was in store for 2018, including number of potential additions to the board during the year-end nominating process.

The committee discussed the uneven nature of board classes. Three board classes in succession rotate 6 board members, while three others in succession rotate 14. The feeling is that a strategy should be developed to even out the board classes so that large numbers of board members aren't terming off at the same time, making continuity challenging.

The committee discussed extending Ken Petersen's term by one year (to 2019) so he can serve as past chair. On a motion by Birt Johnson and a second by Maija West, the committee voted to recommend an extension of Ken's term to the board of directors.

The committee discussed reinstating a practice of board chairs serving two years. The CFMC is very unusual in the field in that it has one-year chairs. The committee feels that two-year chairs provides more continuity of leadership. It was decided that this was a good time to reinstate this practice. On a motion by Maija West and a second by Ken Petersen, the committee voted to recommend moving to two-year chairs.

The committee had a discussion on how to handle communication with board members who have a low percentage of attendance at board meetings. It was decided to approach conversations through asking what barriers are keeping them from good attendance, rather than approach the conversation as punitive.

Dan then gave a summary of the nominating process. There was a general discussion about the ability to remote in board members and the available technology to do so in a quality manner.

With no further business, the meeting was adjourned at 5:10.

Dan Baldwin started the meeting with an agenda overview - #1 Presentation by EMC Planning Group, Inc., #2 Potential Marketing, #3 update by Rick Kennifer. Dan then passed the meeting to Michael Groves and Polaris Kinison Brown of EMC Planning Group Inc.

Michael and Polaris presented their initial findings for 3200 17 Mile Drive's Opportunities and Constraints report. They reviewed the property features, 2 APN numbers with separate addresses (3200 - existing structures built in 1930/1950/1980 and 3204 - a vacant lot), the residential water fixture count survey, and Phase II findings by Subtronic. It was noted that the archeological findings were minimal.

There was a discussion on the existing water credits, the limitations of transferring part of the credits to the vacant lot and purchasing water credits from the Pebble Beach Company. It was concluded that Jim Heisinger would start the process of purchasing 4 allotments of 10 Units of water from the Pebble Beach Company.

Michael discussed the application process with the county for the Certificate of Compliance for each legal parcel of land and that the approval would take approximately 3 months. It was decided that Michael would proceed with the application and Jim would write the attorney opinion letter needed with the application. Michael then reviewed the Phase II findings and it was decided to contract with Subtronic for further investigation for two sites for the possible underground storage tank.

Andrea Edwards then presented the biological findings and identified potential building sites. Due to existing Cypress trees, the buyer(s) would need to have easement rights for part the existing driveway. It was decided that Jim would work on the easement.

Dan then talked about the timeline for the marketing of the property. Bill Mitchell agreed to send Dan an example of an RFP. It was also noted that the property location has a name (Sunset Point) and that Sunset Point will be key in marketing the property.

Rick Kennifer then reviewed the progress of the distribution of the estate and the title transfer. He then reviewed the law regarding statutory interest at 7% for specific bequests not distributed within one year following the date of Charles' death (on August 9, 2017). He informed us that Wells Fargo Bank (WFB) had filed a petition for probate and the hearing will be on July 18, 2018. He also told us that WFB had send a letter regarding the settlement of the estate. After review of the letter it was decided to propose an alternative approach so that the distribution could occur prior to August 9, 2018. Rick will follow up with a letter to WFB with a proposal for distributing the assets to the beneficiaries for Dan to review.

Bill Mitchell discussed the idea of getting a second opinion on the buildable area. Jim also agreed that a second opinion or a peer review would be a good idea. They have both worked with Denise Duffy and suggested that we contract with her to perform the peer review. It was decided that Jim would contract with Denise to do a peer review once we have received the final report from EMC Consulting, Inc.

<u>Assets</u>

Total Assets through 4/30/2018 are **\$262,357,645** a **22.21%** increase since April 2017, and a **1.89%** decrease since December 2017.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2017. In April Marc Rosen added stock valued at \$116,913, with a calculated remainder value of \$14,028.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$1,787, and unrealized losses were \$731,559, for a total loss of \$729,772.

Operating Fund

Total revenue was \$2,235 less than the budget, and total expenses were \$20,927 less than the budget, the realized gains were \$1,010 and the unrealized losses were \$9,536 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$224,308 compared to a budgeted deficit of \$234,474.

Note: The Expendable Operating Cash-on-Hand is at 4.3 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 4/30/2018 was \$186,238,985. The one-year Total Return for the Long-Term Endowment Portfolio was 9.5% compared to the Policy Index of 9.1%.

The market value of the Medium-Term Fund portfolio at 4/30/2018 was \$4,640,338. The one-year Total Return for the Medium-Term Portfolio was 5.0% compared to the Policy Index of 4.8%.

The market value of the ESG Fund portfolio at 4/30/2018 was \$3,297,611. The one-year Total Return for the ESG Fund was 7.8% compared to the Policy Index of 8.0%.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking among those involved in fund development.

Total Special Program revenue was \$424,618 and total expenses were \$108,000.

<u>Assets</u>

Total Assets through 5/31/2018 are **\$265,624,494** a **20.18%** increase since May 2017, and a **0.67%** decrease since December 2017.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2017.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$1,846, and unrealized gains were \$426,028, for a total gain of \$427,874.

Operating Fund

Total revenue was \$38,356 more than the budget, and total expenses were \$28,636 more than the budget, the realized gains were \$1,010 and the unrealized losses were \$6,463 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$447,998 compared to a budgeted deficit of \$452,265.

Note: The Expendable Operating Cash-on-Hand is at 3.4 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 5/31/2018 was \$187,176,746. The one-year Total Return for the Long-Term Endowment Portfolio was 8.9% compared to the Policy Index of 8.5%.

The market value of the Medium-Term Fund portfolio at 5/31/2018 was \$4,804,731. The one-year Total Return for the Long-Term Endowment Portfolio was 4.6% compared to the Policy Index of 4.2%.

The market value of the ESG Fund portfolio at 5/31/2018 was \$3,327,628. The one-year Total Return for the Long-Term Endowment Portfolio was 6.5% compared to the Policy Index of 7.0%.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation.

Total Special Program revenue was \$549,383 and total expenses were \$98,975.
