CALL TO ORDER

Board chair Ken Petersen called the regular meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:30 PM, Tuesday, October 23, 2018 at the Foundation's Monterey office.

Ken Petersen asked the board if they had any questions or required clarification on matters related to the consent agenda. There were no questions or concerns.

REPORT OF THE CHAIR – Ken Petersen

Ken Petersen noted the 2018 Celebration of Philanthropy will be Wednesday, October 24 at Corral de Tierra County Club and encouraged the board to attend. Leon and Sylvia Panetta will receive the Distinguished Trustee Award.

Ken reviewed the remaining 2018 board meeting dates. A "Doodle" calendar poll will be sent to the board to determine the best date for the January 2019 Board Retreat.

TREASURERS REPORT-Teri Belli

Teri Belli reviewed some specific areas of the August and September financial statements. She focused on line items from total cash and investments and compared total support and revenue year to year. There was a discussion by the board on the operating revenue/expenses versus budget.

Motion: to approve the August 31 and September 30, 2018 financial statements.

Bill Sharpe/Birt Johnson, Jr. second. Motion carried unanimously.

Teri updated the board on the 2019 budget process and timeline. The finance committee has approved the 2019 budget. The Executive Committee will review the budget in November and make a recommendation at the December board meeting.

INVESTMENT COMMITTEE – Ken Petersen for Steve McGowan

Ken Petersen reviewed the current positions of the Long Term, Medium Term and ESG portfolios. At the next investment committee meeting on November 12, the committee will review the 2019 spending policy.

Community Impact Investment Committee – Nolan Kennedy

The committee has worked out the loan terms for two organizations and created a loan package with assistance of attorney, Hanson Reed. There is underwriting analysis underway as well. The committee hopes to have the loans completed and distributed by the end of the year.

RESOURCE DEVELOPMENT – Betsy Buchalter Adler – call in

Betsy Buchalter Adler reported on the August and September Resource Development Summaries.

Betsy and Ida Lopez Chan highlighted the Siembra Latinos Fund launch that took place September 27 at the Taylor Farms Building in Salinas. The event had a good turn out and the advisory board is working hard to keep the energy moving forward with the inclusion of Siembra Latinos Fund in the 2018 MC Gives campaign.

Betsy described the next donor education program: 2018 CFMC – October 30 12:00-1:30 p.m. featuring Gail Delorey CPA, *Charitable Giving and the New Tax Law*.

Dan updated the board on the MC Gives campaign that will launch on November 8. The “challenge gifts” that are sent before the campaign begins have outpaced the 2017 gifts. The new tax laws create a question of uncertainty on how people will give in 2018, but the Philanthropic Services team has been working hard to educate donors and non-profits on the use of IRA charitable rollover donations to the MC Gives! campaign.

GOVERNANCE COMMITTEE – Dan Baldwin for Steve McGowan-call-in

Dan Baldwin reported the Governance Committee met September 18 and identified 6 candidates for the 2019 board recruitment. This includes investment, advocacy, community leadership, banking and education with consideration for gender, ethnic diversity, age, personal skills and geography.

The recommended names were presented to the board with a request for any concerns or comments to be sent to Dan by Friday, October 26. The final list of three candidates and the 2019 officers will be presented at the December board meeting.

GRANTS AND PROGRAMS – Birt Johnson, Jr.

Birt Johnson, Jr. requested approval of the August 1 – September 30, 2018 grants. There are 209 grants totaling \$2,720,261.

Motion: to approve 209 grants awarded from August 1 – September 30, 2018, totaling \$2,720,261.

Erika Padilla Chavez / Ida Lopez Chan second. Motion carried unanimously.

PRESIDENT’S REPORT – Dan Baldwin

Dan sent an electronic report to the board prior to the meeting.

3200 17 Mile Drive Real Estate – Dan Baldwin

Update:

The generation skipping trust has been liquidated and CFMC has received \$274,000 from Wells Fargo Bank. The personal trust funds of Charles de Guigne will arrive in late 2018 or early 2019. The proceeds of the sale of the property will repay funds that were forwarded to Wells Fargo to pay bequest beneficiaries.

Dan and Ken Petersen have been speaking with the CFMC legal counsel and the County Assessor about a nonprofit exemption on the property tax while CFMC has ownership. The CFMC has filed a “welfare exemption” and legal memo with the County Assessor who will forward it to the state Board of Equalization. If the tax exemption is rejected, the CFMC board will discuss next steps.

Board Site Visit:

Board members were invited to tour the property in the first week of October.

Process once offer is presented:

The Real Estate committee and CFMC legal counsel had a thorough discussion about the process needed to respond to an offer on the de Guigne properties. It was suggested the Board delegate a small committee to handle the offers consisting of Chair, Vice Chair and Dan. The Real Estate committee recommends the small committee consist of chair, vice-chair and Bill Mitchell with the real

estate committee members informed by email. They would like to respond to any offers within five work days.

The CFMC LLC own the lots at 3200 17 Mile Drive and the CEO is the manager of the LLC and authorized to complete real estate transactions in the name of the Community Foundation for Monterey County. Because of the scale of the 3200 17 Mile Drive, Dan asked the CFMC legal counsel to draft a resolution to authorize Dan to enter into real estate transactions. The title company may request proof of authorization.

"RESOLVED that Daniel R. Baldwin, Manager of Community Foundation for Monterey County Real Estate Number 1 LLC is hereby authorized and directed to transact, negotiate and enter into any and all real estate transactions by or in the name of said LLC for the benefit of the Community Foundation for Monterey County, the LLC's sole member, and in connection therewith to execute and deliver, in the name of the corporation Deeds, Mortgages/Deeds of Trust, Notes, Agreements for Sale, Escrow Instructions and any and all instruments necessary to properly consummate such transactions in accordance with the purpose of this resolution."

Motion: to approve the 2018 resolution authorizing Daniel R. Baldwin to enter into real estate transactions.

Maija West / Birt Johnson, Jr. second. Motion carried unanimously.

Ken Petersen called the regular meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:33 on November 27, 2018 at the Foundation's Salinas office.

APPROVAL OF MINUTES

REPORT OF THE CHAIR – Ken Petersen

Ken Petersen asked for feedback on the Celebration of Philanthropy held October 24 at Corral de Tierra County Club. There were positive comments about the smooth logistics of the reversed room set-up for seating and high-quality food presented. Comments on the flow of entering the room from the patio and stage lighting were noted for next year. The timing of the overall presentation was appreciated, and the program did not seem too long. The youthful scholarship recipient, Blanca Zarazua, Esq, and Sylvia and Leon Panetta's comments all had strong, inspiring messages. Corral de Tierra received high praise for the professional and seamless operation.

Ken reminded the committee about the board and spouse Holiday Social, December 18, at 5:45, after the board meeting.

The preferred date for the 2019 Board Retreat is Saturday, January 26, 8:45AM to 1:00PM. The board will confirm the date at the December meeting and discuss agenda items. The theme will be around advocacy and the third tenet of the strategic plan, *Community Leadership*.

TREASURERS REPORT-Teri Belli

Teri Belli reported the October and November 2018 financials will be approved at the December board meeting.

The 2019 budget has been reviewed by the Finance Committee. Teri summarized the budget notes and assumptions and asked for questions and comments. The 2019 budget will be presented for approval at the December 18 board meeting.

RESOURCE DEVELOPMENT COMMITTEE - Betsy Buchalter Adler

Betsy Buchalter Adler reported the donor education program presented on October 30, titled *Charitable Giving and the New Tax Law*, by Gail Delorey, CPA, was well attended. Betsy reviewed the November event attendance summary and highlighted the wide range of events CFMC attends.

Christine Dawson reported the opportunity for donors to use their IRA qualified charitable distributions for donations at year end of 2018 is proving successful.

The next Resource Development Committee meeting is December 12, 2018.

Laurel Lee Alexander reported the James Irvine Foundation grant process is going well and that staff are reviewing grant applications for the first year of grantmaking. The community team is identifying key areas of interest and leverage for 2019 grantmaking.

INVESTMENT COMMITTEE – Steve McGowan - call in

Steve McGowan reported on the November 12 Investment Committee meeting. The committee reviewed the 2019 spending policy based on the evaluation of the CFMC's investment objectives, mission and strategic plan. After a thorough discussion the committee decided on a 4.5% spending policy for 2019.

Motion: to recommend for approval at the December 19 board meeting a 4.5% payout rate on endowed funds for 2019.

The committee reviewed the requirements of Verus and Anne Westritch, and discussed Verus' performance. At the end of the discussion the committee approved maintaining the relationship with Verus for another year.

Steve McGowan reported the Governance Committee contacted the three candidates nominated to the 2019 board. Two of the three have all agreed to serve on the board and the third person will respond in the next week. The new board members will be presented for approval at the December 18 board meeting.

Birt Johnson, Jr., Teri Belli, Betsy Buchalter Adler and Bill Sharpe have been contacted for a second term. Birt, Teri and Betsy have all agreed to a second term and Bill Sharpe will respond in the next week.

Homeless Services Update

Dan reported that he has hosted meetings in Salinas and Monterey to help cities and homeless services providers align around priorities and projects that will utilize approximately \$10.5 million in HEAP funds (Homeless Emergency Aid Program) coming to Monterey County. The process is being overseen by the Leadership Council, of Dan is a member. He has offered to have the CFMC assist with the development of an RFP for the funds, as this will closely resemble a grant application.

League of California Community Foundations meeting

Dan reported on the recent annual meeting with the League of California Community Foundations in Oakland, CA. The topics included donor advised funds and advocacy in Sacramento for Community Foundations in 2019.

Monterey County Gives!

Dan reported MC Gives is about 10% above the 2017 campaign to date. Dan described the unpredictable nature in this year due to the changes in the tax law.

Financial Statement Review

Teri Belli led a discussion on the August and September Financial Statements. She reviewed the significant changes in the YTD Consolidated Statement of Financial Position and the operating revenue/expenses versus budget. There was a discussion by the committee on the significant changes. Dan Baldwin reviewed the de Guigne expenses, income and the status of the property tax appeal.

The regular meeting of the Investment Committee (IC) of the Community Foundation for Monterey County was called to order by Steve McGowan at 3:00 PM on November 12, 2018.

Minutes

On a motion by Ken Petersen, seconded by Bill Doolittle, the August 13, 2018 minutes were approved as written.

Steve McGowan reviewed the 2019 meeting dates with the committee.

Verus

Steve then passed the meeting to Anne Westreich to discuss the asset allocation.

Anne brought the committee up to date with the 2012 IPS Targets approved by the board, the 2016 Committee Targets approved by the board and the current allocations. She then reviewed the changes to the asset allocations that were approved since 2012 and the foundations objectives. After a long discussion, they decided to have Anne start the process of revising the IPS. They requested that she start with incorporating the 2016 Committee Targets approved by the board to the existing IPS. Anne agreed to have a draft ready for the committee in January.

Steve and Dan led a conversation regarding the Annual Spending Policy Payout Percentage. The committee discussed the importance of keeping the payout consistent, and agreed to recommend to the Board a 4.5% payout for the 2019 distribution.

Anne reviewed the third quarter 2018 investment results.

The market value of the Total Fund portfolio at 9/30/2018 was \$183,021,552. The YTD returns were 2.8% compared to the policy benchmark of 2.2%.

The market value of the Medium-Term portfolio at 9/30/2018 was \$4,824,496. The YTD returns were 0.9% compared to the policy benchmark of 0.7%.

The market value of the ESG portfolio at 9/30/2018 was \$3,575,288. The YTD returns were 2.4% compared to the policy benchmark of 2.7%.

Steve led a discussion regarding the performance of Anne and Verus. The committee agreed that they were doing an excellent job and to continue with their services.

Call to Order: The regular meeting of the Endowment Stewardship Committee of the Community Foundation for Monterey County (CFMC) was called to order at 2:01 PM by Betsey Pearson at the CFMC's Monterey office.

Approval of minutes: Motion: Greg Chilton/second: Betsy Buchalter Adler; motion carried.

Update

1. The committee reviewed the MARKS fund at the last meeting. It appeared that the MARKS fund supported three grants in 2016 which may have been outside the scope of the fund's field of interests (seniors and animals). Staff was asked to review the three grants. The grants of concern were
 - a. Food Bank – The MARKS fund supported \$15,000 of this \$40,000 Community Impact grant. The purpose of the grant was to support operating expenses to increase the number of food distribution sites addressing growing needs of children and seniors.
 - b. CASA – The MARKS fund supported \$700 of this \$35,000 Community Impact grant for operating support. This was a staff error.
 - c. Ventana Wilderness Alliance – The Marks fund paid 100% of this \$10,000 grant for youth outdoor education. This was a staff error. These funds were allocated for an animal welfare grant (under the Environment & Animal Welfare program area).

Staff have already instituted measures to decrease the likelihood of repeating these errors. The committee accepted staff's explanation and agreed that no further action is needed.

Fund Review

2. Committee members reviewed fund summaries, grant history and legal agreements of nine funds. Betsey and Janet co-facilitated the committee's discussion of these funds.

1. Boys and Girls Club (Restricted Agency fund)

Assets

Total Assets through 10/31/2018 are \$256,062,308 a 11.38% increase since October 2017, and a 4.25% decrease since December 2017.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2017.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$136,749, and unrealized losses were \$7,005,918, for a total loss of \$6,869,169.

Operating Fund

Total revenue was \$2,921 more than the budget, and total expenses were \$63,105 less than the budget, the realized gains were \$1,010 and the unrealized losses were \$25,745 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$229,483 compared to a budgeted deficit of \$270,774.

Note: The Expendable Operating Cash-on-Hand is at 6.9 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000, and including the de Guigne bequest.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 10/31/2018 was \$174,925,134. The one-year Total Return for the Long-Term Endowment Portfolio was -0.1% compared to the Policy Index of -0.2%.

The market value of the Medium-Term Fund portfolio at 10/31/2018 was \$4,653,567. The one-year Total Return for the Long-Term Endowment Portfolio was -1.3% compared to the Policy Index of -1.1%.

The market value of the ESG Fund portfolio at 10/31/2018 was \$3,380,555. The one-year Total Return for the Long-Term Endowment Portfolio was -0.8% compared to the Policy Index of -0.2%.

The market value of the DRIM Fund portfolio at 10/31/2018 was \$2,960,855. The Total Return for the DRIM Portfolio, since inception, was 0.3% compared to the Policy Index of 0.6%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation.

Total Special Program revenue was \$2,529,474 and total expenses were \$525,950.

Assets

Total Assets through 10/31/2018 are \$256,062,308 a 11.38% increase since October 2017, and a 4.25% decrease since December 2017.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2017.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$136,749, and unrealized losses were \$7,005,918, for a total loss of \$6,869,169.

Operating Fund

Total revenue was \$2,921 more than the budget, and total expenses were \$63,105 less than the budget, the realized gains were \$1,010 and the unrealized losses were \$25,745 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$229,483 compared to a budgeted deficit of \$270,774.

Note: The Expendable Operating Cash-on-Hand is at 6.9 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000, and including the de Guigne bequest.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 11/30/2018 was \$176,399,988. The one-year Total Return for the Long-Term Endowment Portfolio was -0.1% compared to the Policy Index of -0.7%.

The market value of the Medium-Term Fund portfolio at 11/30/2018 was \$4,677,465. The one-year Total Return for the Long-Term Endowment Portfolio was -1.1% compared to the Policy Index of -0.8%.

The market value of the ESG Fund portfolio at 11/30/2018 was \$3,417,505. The one-year Total Return for the Long-Term Endowment Portfolio was -0.7% compared to the Policy Index of -0.5%.

The market value of the DRIM Fund portfolio at 11/30/2018 was \$2,768,669. The Total Return for the DRIM Portfolio, since inception, was -0.5% compared to the Policy Index of -7.0%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation.

Total Special Program revenue was \$2,529,474 and total expenses were \$525,950.

2019 Operating Budget Notes & Assumptions

2018 YEAR END

Current year-end projection includes net income of \$150,152. The de Guigne property is not included in the year-end forecast.

Year-end projections include:

Contribution revenue is over budget, primarily due to receipt of a grant from the Starlight Foundation, in the amount of \$10,000. The forecast assumes the annual appeal generates the budgeted amount for individual contributions.

Administrative fee revenue is under budget. Due to drop in the market, as of November 30th, the portfolio has recorded a year-to-date unrealized loss of almost \$4.9 million, resulting in lower fund balances, generating lower administrative fees.

Personnel costs are lower than budgeted due to vacant positions.

Administrative costs are over budget due to the following:

- Bank Charges – increase in credit card contributions
- Postage – increased number of acknowledgement letters, and mailings for North and South County events
- Contract Services – Systems Operations Manager/IT consultant, not budgeted
- Conferences & Trainings – eliminated some scheduled trainings
- Accounting Services – audit/accounting expense less than budgeted
- Legal Services – fewer legal expenses than expected
- Misc. Admin Expense – WF lunch proceeds transfer less than expected, off-set by ticket sales and sponsorships
- Depreciation Expense – reduced due to the timing of capital purchases

Occupancy, Program and Development costs are slightly under budget.

OPERATING CASH RESERVE

The unrestricted cash available as of November 30, 2018, is \$1,494,952, representing a reserve of 6.1 months.

2019 BUDGET

2019 includes revenues of \$3,272,034, and expenses of \$3,264,946, for a net surplus of \$7,088.

REVENUE

Contributions

- Bequests Received includes a five-year average for unknown bequests received directly, and payments on bequests receivable
- Contributions – Individuals, Corporate & Foundations are based on a five-year average
- Contributions – Interfund includes the annual payout from the operating endowment, and a five-year average of contributions received from donor advised funds

Administrative Fees

- 2019 budget based on September 30 fund balances
 - Due to the volatility of the stock market, and its effect on fund balances, this amount is subject to change with each month-end.
- Includes \$64,680 from the Monterey County Gives campaign
- Fees from CRTs include quarterly fees from Kaspick
- Special Program Fees includes amounts paid by third-party funded programs for administrative overhead expenses
- Workshop revenue increased due to the return of LEAD activities for 2019

EXPENSES

Salaries and benefits

- Assumes 5% increase over the current salary structure, which includes a 2% discretionary merit pool; the CPI as of October 2018 is 4.4%
- Includes the addition of the Director of Special Initiatives position
- Health plan policy Blue Shield Silver Savings 2,000/4,000
- Medical, dental, vision and long-term disability paid 100% for the employee
- \$2,000 HSA contribution for all eligible staff
- Retirement includes a 6% 403(b) contribution for all eligible employees

Administrative expenses

- Database maintenance includes FIMS, our operating database, and Foundant, our online grant processing program
 - 45.62% increase due to the move to a hosted network, and the addition of three user licenses.
- Contract Services includes Donor Central, Crescendo and SOM/IT consultant
- Conferences and professional development increased, due to new board members and staff attendance at the Council on Foundations Fundamental Course
- \$76,113 depreciation expense for \$28,000 new capital purchases, \$95,800 building improvements, plus building depreciation
 - Building improvements are depreciated over 39 years

Occupancy

- Monterey includes a 4% increase in loan payments, and property taxes on the land only
- Salinas rent includes a 3% increase

Development & Staff

- Donor Development includes increased amounts for the Women's Fund luncheon, which is offset by the ticket sales and sponsorships, and an increase for the Legacy Society luncheon
- Workshop & Assemblies increased due to the return of LEAD activities for 2019
 - There was not a 2018 LEAD class; however, there were some LEAD alumni activities
- Annual Events expense increased due to expected increase in attendance
- Annual Report expense increased due to increased mailing list

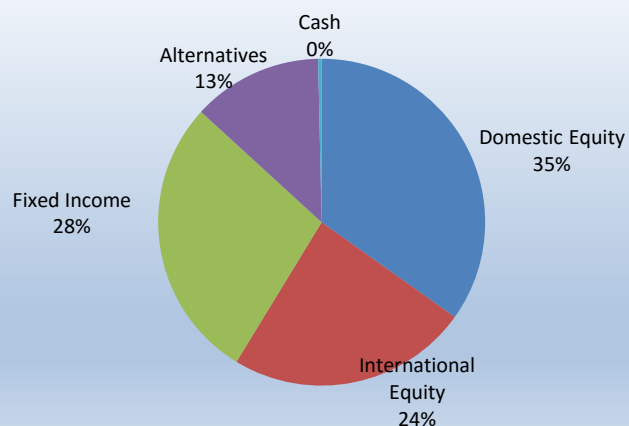

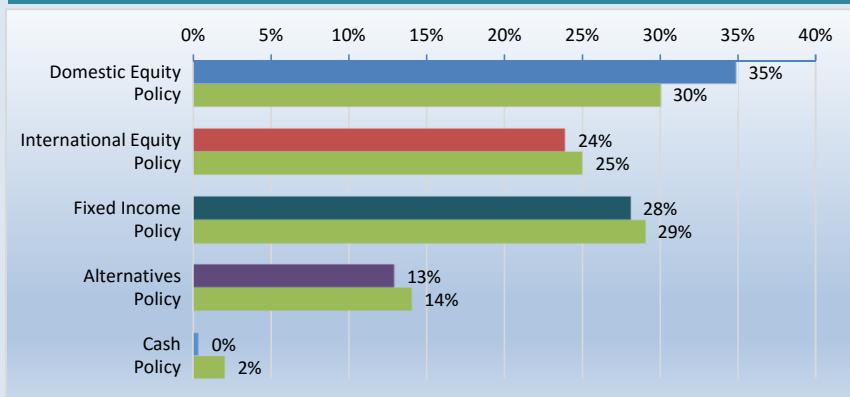
ASSET ALLOCATION \$176,098,496 at 11/30/2018

Performance QTD through 11/30/2018

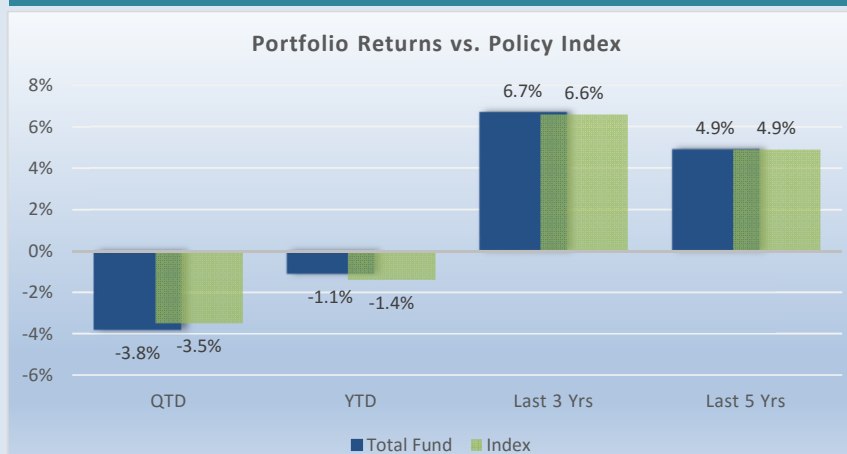

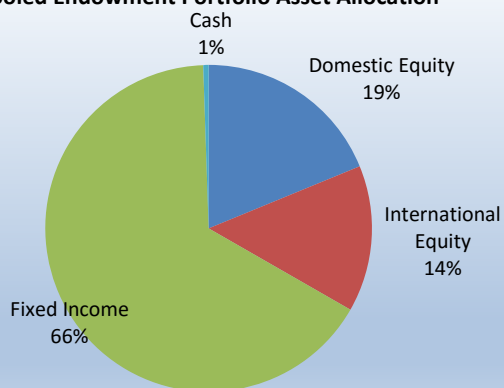

Pooled Endowment Portfolio Asset Allocation

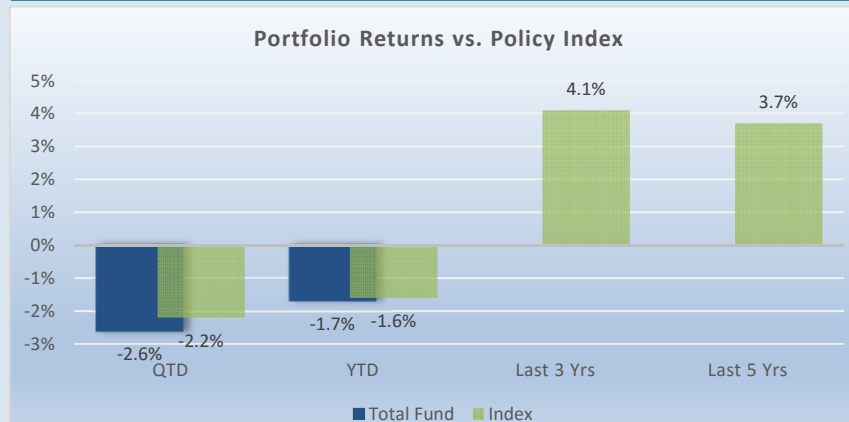

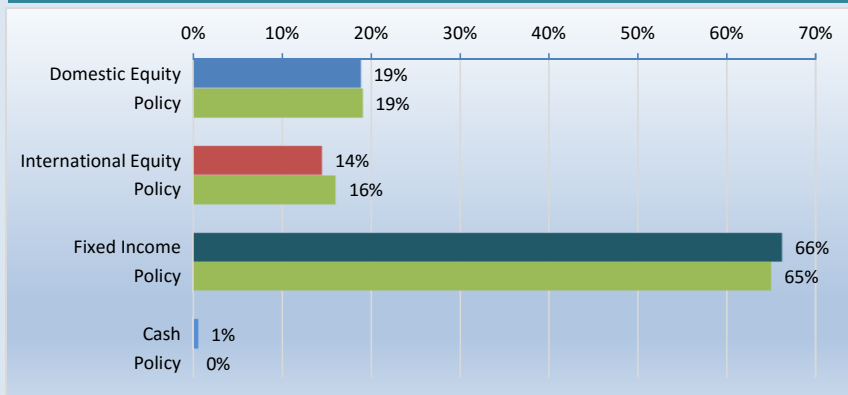

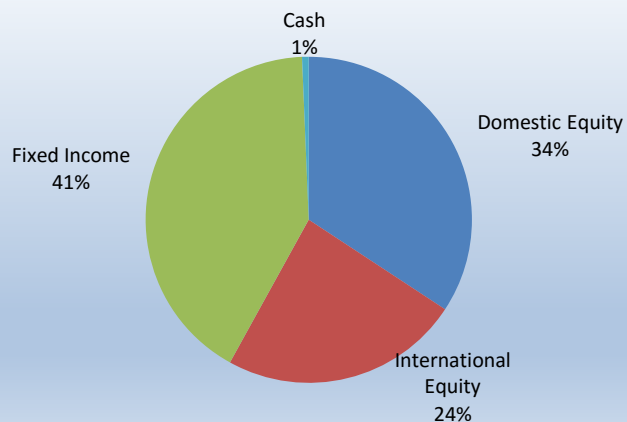

- The MSCI Emerging Markets Index outperformed, gaining 4.1% and benefitting from slight currency tailwinds. Meanwhile, the MSCI ACWI Index gained 1.5% and the MSCI EAFE Index fell 0.1%.

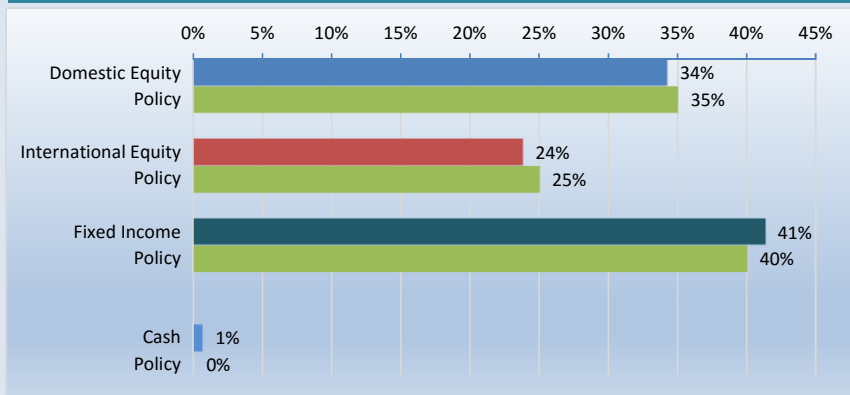

Performance QTD through 11/30/2018

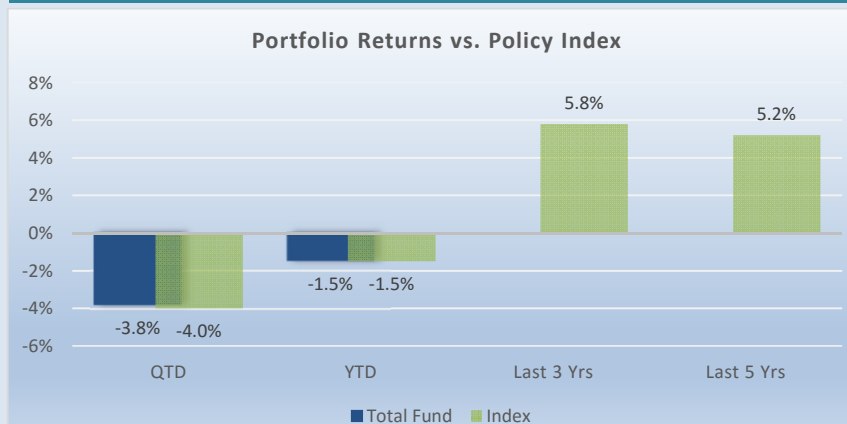

VERUS NOVEMBER CAPITAL MARKETS UPDATE

THE ECONOMIC CLIMATE

- Non-farm payrolls added 155,000 jobs in November, missing expectations of 198,000, and the unemployment rate held steady at 3.7%. The labor force participation rate remained at 62.9%, materially below the 66.0% level which prevailed from 2004 through 2008.
- The Italian composite PMI for November was unchanged at 49.3, indicating economic contraction over the past two months, and underscoring the importance of a budget resolution.

MARKET PORTFOLIO IMPACTS

- The S&P 500 Index gained 2.0% in November, weathering a sustained pick-up in volatility. The 30-day implied volatility of the index ended the month at 15.9, above its 50-day moving average of 15.3.
- S&P 500 companies posted aggregate earnings and sales growth of 25.9% and 9.3% YoY in Q3, respectively. According to FactSet, analysts expect Q4 earnings and sales growth of 13.6% and 6.7% YoY, respectively. Of the 97 companies providing EPS guidance, 69% have been negative, in-line with the 5-year average.
- Market expectations for future Fed rate hikes declined significantly, influenced by Powell's dovish comments referenced above. While the market is still expecting a hike in December, it is no longer pricing in any additional hikes in 2019.
- The MSCI Emerging Markets Index outperformed, gaining 4.1% and benefitting from slight currency tailwinds. Meanwhile, the MSCI ACWI Index gained 1.5% and the MSCI EAFE Index fell 0.1%.
