CALL TO ORDER

Board chair Birt Johnson, Jr. called the regular meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:37 PM, Tuesday, June 25, 2019 at the Foundation's Salinas office.

CONSENT AGENDA – Birt Johnson, Jr.

Birt Johnson asked the board if they had any questions or required clarification on matters related to the consent agenda. He noted the inclusion of the recommended term extension for Ida Lopez Chan for one year. There were no questions or concerns.

Motion: to approve the Consent Agenda as presented.

Bill Mitchell / Betsy Buchalter Adler, second. Motion carried unanimously.

REPORT OF THE CHAIR – Birt Johnson

Birt Johnson discussed the idea of allowing more time in board meetings for discussions and education on relevant topics. The agendas will focus on timed and streamlined committee reports.

Birt reported on the League of California Community Foundations (LCCF) CEO/Chair retreat in May that he and Dan attended in Sacramento. The topics ranged from AB1712 about donor advised funds, disaster planning, affordable housing and lobbying efforts by the league.

Birt reviewed the Distinguished Trustee award which is presented each Fall at the Celebration of Philanthropy. The executive committee had discussed the list of candidates and recommend the first

choice of Lydia Villareal and Joel and Dena Gambord as the alternate. The board discussed the qualities of the recommendations and agreed to approve Lydia Villareal as the 2019 Distinguished Trustee

Motion: to approve Lydia Villareal as the 2019 Distinguished Trustee and Joel and Dena Gambord as an alternate if Lydia Villareal declines.

Abby Taylor-Silva /Betsy Buchalter Adler second. Motion carried unanimously.

Birt described the board survey included in the packet. It will help create an accurate matrix for the development of diversity, geography and expertise on the board. A separate email will go out from the governance committee with the survey questions for the board to complete.

TREASURER/FINANCE COMMITTEE – Jan Vanderbilt

Jan reviewed the five-month financials ending on May 31, 2019. She highlighted total new contributions and change in net assets for April and May. Jan reviewed the combined operating fund budget vs. actual. After a discussion the board recommended approval of the financials.

Motion: to approve the five months Financial Statements ending May 31, 2019. Jan Vanderbilt / Loren Steck, second. Motion carried unanimously.

Jan reported the 2018 Form 990 went through a detailed review at the finance committee meeting. Jan recommended the approval of the 2018 990.

Motion: to approve the 2018 Form 990 as presented.

Michael Reid / Nolan Kennedy second. Motion carried unanimously.

Jan reviewed the operating reserve policy amendments presented by the finance committee to the board for approval. The board discussed the language changes and agreed to approve the policy as presented.

Motion: to approve the recommendations of the finance committee to the operating reserve policy as presented.

Loren Steck /Elsa Jimenez second. Motion carried unanimously.

COMMUNITY IMPACT INVESTING – Nolan Kennedy

Nolan Kennedy reported on the June 17 meeting. The committee is researching opportunities for investments into affordable housing. There is up to \$1.85 million available to invest based on the Investment Policy guidelines.

RESOURCE DEVELOPMENT – Michael Reid

Michael Reid reported the next Resource Development meeting is June 26.

Christine Dawson highlighted the success of the Women's Fund Luncheon held in May which raised \$140,000 to date and attracted 590 attendees.

The Planned Giving Professionals Education Seminar Luncheon, which featured speaker Erik Dryburgh, JD CPA from Adler & Colvin, was very well received. It was co-presented with Montage Health Foundation.

GRANTS AND PROGRAMS – Ida Lopez Chan

Ida Lopez Chan requested approval of the April 1, 2019-May 31, 2019. There are 305 grants totaling \$3,146,341.

Motion: to approve 305 grants awarded from April 1, 2019-May 31, 2019, totaling \$3,146,341. Bill Sharpe / Betsy Buchalter Adler, second. Motion carried unanimously.

Ida described 2 donor advised grants for approval that are not on the agenda.

1. The Landreth Family Fund

Agency: Big Sur Land Trust

Amount: \$160,000

Purpose: Supplemental campaign gift (\$100,000); Previous campaign gift (\$50,000); Annual

contribution (\$10,000)

2. Buffett Fund

Agency: Monterey Symphony

Purpose: help with expenses for the search of a new conductor

Motion: to approve \$160,000 to the Big Sur Land Trust from the Landreth Fund and \$50,000 to Monterey Symphony from the Buffett Fund.

Ida Lopez Chan / Michael Reid, second. Motion carried unanimously.

Ida reported the 2019 Community Impact Grants spring cycle is complete. There are 41 grants in the Health and Human Services and Children and Youth Development areas totaling \$1,359,750.

Betsey Pearson shared her experience working on the review committee and appreciated the collegial discussions and good decisions the committee made.

Motion: to approve the 41 Community Impact Spring 2019 cycle grants totaling \$1,359,750. Ida Lopez Chan/ Nolan Kennedy, second. Motion carried unanimously.

NEW FUNDS – Dan Baldwin

Dan informed the board that a new Charitable Remainder Annuity Trust (CRAT) with a real estate component and annual payout will be completed after the board meeting and will be approved by the executive committee if necessary.

PRESIDENT'S REPORT - Dan Baldwin

Dan sent an electronic report to the board prior to the meeting.

3200 17 Mile Drive

Dan reviewed the tax position on 3200 17 Mile Drive and reported an adjustment in the assessed property value will affect the property taxes due, retroactively.

Legislative update

Dan reported on the success of the legislative work surrounding AB1712 (the bill requires significant reporting on donor advised funds). He presented a PowerPoint on "Next Steps on DAF's AB1712 and How We Shift the Narrative."

Birt welcomed Nolan Kennedy, the chair of the Community Impact Investment Committee, which Birt designated as a standing committee and part of the executive committee going forward.

REPORT OF THE CHAIR - Birt Johnson, Jr.

Birt reported the Celebration of Philanthropy will be October 30, 2019 at Corral de Tierra County Club. Lydia Villareal has agreed to receive the Distinguished Trustee Award.

Birt informed the executive committee that Jeff Eikenberry is moving out of the area and will resign after the August 27 board meeting.

TREASURERS REPORT - Jan Vanderbilt

Jan Vanderbilt reported the June and July financial statements will be reviewed and approved at the August board meeting.

GRANTS AND PROGRAMS COMMITTEE – Ida Lopez Chan

Ida Lopez Chan recommended approval of the donor advised, interfund transfers and other grants over \$50.000.

1. Harles R. Sarmont College Endowment Fund (Interfund)

Motion: to approve the grants from the Harles R. Sarmont College Endowment Fund to the College Futures Monterey County Fund for \$162,326.66, The College Futures Monterey County Fund to The College Futures Monterey County Fund for \$200,000 and Lori and Lou Flagg Memorial Youth Fund to the Boys and Girls Clubs of Monterey County for \$50,000.

Ida Lopez Chan / Nolan Kennedy second. Motion carried unanimously

Laurel Lee-Alexander reported the Endowment Stewardship Committee met July 15. They discovered the Harles R. Sarmont Fund had an incomplete motion from October 2015.

Excerpt from the October 27, 2015 Board meeting minutes with needed text in red:

PRESIDENTS REPORT – Dan Baldwin

"Dan described the Harles R. Sarment College Endowment is the CFMC's largest scholarship fund, with a \$2.2 million balance and over \$100,000 in scholarships awarded each year to graduating high school seniors throughout Monterey County. The criteria were written many years ago, and they called for the scholarships to be tuition only.

Dan recommends the CFMC Board exercise its power of variance to change the criteria to the following:

"Only the income from the fund may be used and, when used, shall be used for the exclusive purpose of providing tuition scholarships to persons who meet all of the following five qualifications:

- 1. Graduating high school senior.
- 2. Resident of Monterey County.
- 3. United States citizen.
- 4. Admitted as a full-time student into a <u>two-year or</u> four-year college or university in the United States for the first academic year following graduation.
- 5. Otherwise financially unable to attend such a college or university."

Motion: to approve the CFMC board exercise its power of variance to adjust the language in the Harles R. Sarment College Endowment and change the word "tuition" to "scholarships and add "two-vear or" to Criteria #4."

Ida Lopez Chan/ Jeff Eikenberry second. Motion carried unanimously

INVESTMENT COMMITTEE – Ken Petersen

Ken reported on the portfolio reviews and performance allocations for the Long Term, ESG and Medium Term portfolios.

The committee's next meeting is August 12, when the draft of the 2019 Investment Policy Statement will be reviewed. Steve Dart, Anne Westritch, Ken Petersen and Dan Baldwin have been preparing

the new draft. It will go before the executive committee in November and the board in December for approval.

GOVERNANCE COMMITTEE - Dan Baldwin for Ken Petersen

Dan reported the committee will meet August 13 to review the survey results and outline the skill sets needed for 2020 board members. They will meet in September and October if necessary, to finalize potential board candidates.

The committee will recommend a new secretary for approval at the August board meeting to take Jeff Eikenberry's position.

Dan described the new CRAT created by Steve and Barbara Brooks that includes real estate in Carmel, CA. He outlined the obligations created by the 7% annuity when the CFMC is the trustee. After a thorough discussion the committee agreed to approve accepting the role of trustee for the Brooks CRAT.

Motion: to approve The Brooks Charitable Remainder Annuity Trust. Ken Petersen / Teri Belli second. Motion carried unanimously

PRESIDENT/CEO REPORT - Dan Baldwin

75th Anniversary

Dan informed the committee that staff research shows the CFMC will have its 75th Anniversary in 2020. Dan proposed the staff and board engage past chairs and board members as an advisory committee to set the direction of the anniversary and aspirations of the CFMC looking forward.

Motion: to create an advisory for the CFMC's 75th Anniversary. Ken Petersen / Teri Belli second. Motion carried unanimously

Dan reported the highlights of the Past Chairs luncheon was the continual commitment and goodwill shared by the CFMC's past chairs.

Advocacy Guidelines

The committee discussed the proposed advocacy guidelines at length. Dan noted the CFMC does not have a formal set of guidelines and as we move into a more public profile, the guidelines will tell the CFMC how and when to act.

A recommendation was made to present the advocacy guidelines to the board at the August 27 meeting for approval. The committee would like the documents sent out early and time allotted at the meeting for a presentation and discussion about some of the critical points and IRS standard statements.

Motion: to recommend the advocacy guidelines for approval, with a presentation and discussion, to the board at the August 27, 2019 meeting.

Dan reported on the progress of his 2019 goals. He summarized the topics of; advocacy, leadership, community impact investing, affiliate funds, DAF's, College Futures and Census 2020 and general operations.

The market value of the ESG portfolio at 6/30/2019 was \$3,693,164. The YTD returns were 11.3% compared to the policy benchmark of 12.6%.

The Community Impact Investment Committee of the Community Foundation for Monterey County was called to order by Nolan Kennedy at 3:30 PM on August 19, 2019.

Nolan turned the meeting over to Dan Baldwin.

Dan reviewed the agenda and purpose of the meeting and introduced Susan True.

Susan True reported on the experiences with the holdings in their Impact Investment Portfolio, including:

- Opportunity Fund
 - Felt distanced from the program
- New Way Homes
 - o This is their holding with the most risk
- FarmLink
- Landed
 - Difficult to work with because they kept changing things
 - o Due to be paid in full within a month
 - CFSCC was able to participate in new home loans for 18 teachers
- Homeless Services Center
 - This is their first direct loan to a non-profit agency

They are just beginning a partnership Habitat for Humanity, to develop the infrastructure for an 11-unit affordable housing project in the Live Oak area.

They are also beginning a partnership with Community Capital Management, as part of their ESG portfolio.

They have had success with Donor Advised Fund participation with their Community Involvement Revolving Fund, and the advisors not expecting the interest being credited back to their individual funds.

Patrick Cleary joined the meeting via ZOOM and reviewed the program at HACF, which started 10-years ago, because Easter Seals was pulling out of the area, and they were going to lose some community services.

The majority of their partnerships are with Community Development Financial Institutions; however, they do have a small loan program, which makes small direct loans.

Dan Baldwin reviewed the details of his conversation with Community Capital Management (CCM), including:

- CCM is a mutual fund, and can be purchased through Schwab
- There is no minimum investment, unless your investment is geographically specific
- The minimum for geographically specific investments is \$500,000
- It is a fixed income investment and returns are based on loans for mortgages
- CCM currently has \$3.9 million invested in Monterey County
- CCM could place another \$2.5 \$3 million in the next 6-months

The committee discussed investing in CCM and at the conclusion decided it was not an investment option for our Community Impact Investing program.

The committee discussed more direct investments, such as affordable housing units for entry level managers, direct loans and how to source them to find customers.

Next steps will be for Dan Baldwin and Nolan Kennedy to meet and discuss identifying potential partners, and then schedule a meeting to review their findings with the full committee.

Having no further business, the meeting was adjourned 5:25PM.

Call to Order: The regular meeting of the Endowment Stewardship Committee of the Community Foundation for Monterey County (CFMC) was called to order at 2:03 PM by Betsey Pearson at the CFMC's Monterey office.

Approval of minutes: Motion: Greg Chilton/second: Ken Petersen; motion carried.

Welcome

New members were welcomed. Staff recapped the purpose of the committee.

- All funds are endowed.
- Fund summaries include the date the fund was established, amount of the establishing gift, current fund balance and amount available for the current year (which is calculated on a rolling 12-quarter fund balance average, as of September 30)
- The Investment Committee recommends the spending policy percentage to the full board for approval. For the last several years, the amount has been 4.5%.

Update

- 1. The committee reviewed the following four funds and asked staff to clarify some areas.
 - a. <u>Boys & Girls Clubs of Monterey</u> (Restricted Agency): The legal agreement stated that the fund fee would be 1%. Committee asked staff to confirm if this is current. Staff shared that fees are subject to change and this fund falls under the cumulative fee structure (1.25% for balances under \$1 million).
 - **ACTION Item**: Committee asked when nonprofit was notified of rate change.
 - b. <u>United Way of Monterey County Fund</u> (Restricted Agency): The legal agreement stated that the fund fee would be 1%. Committee asked staff to confirm if this is current. This fund falls under the cumulative fee structure (1.25% for balances under \$1 million).
 - **ACTION Item**: Committee asked when nonprofit was notified of rate change.
 - c. <u>York School</u> (Restricted Agency): Legal agreement stated that the fund name would be "York School Scholarship Endowment Fund". Committee asked staff to confirm if payouts are restricted to scholarships and if payouts for "general operating support" fits the original purpose of the fund. Staff reviewed with Dan who confirmed that this is an agency endowment fund, to be used as the nonprofit's discretion.
 - **ACTION Item:** Staff to confirm York would like the fund name to be updated.
 - d. <u>Casa Amesti Foundation Building</u> (Restricted Agency), <u>Herman Fletcher</u> (Designated Agency) and <u>Casa Amesti Garden and House</u> (non-endowed fund): Three Casa Amesti-related funds **ACTION Item**: Review all three Casa Amesti-related funds with Dan and Philanthropic Services team

The committee accepted staff's explanation and agreed that no further action is needed.

Fund Review

2. Committee members reviewed fund summaries, grant history and legal agreements of 16 funds. Betsey facilitated the committee's discussion of these funds.

Assets

Total Assets through 5/31/2019 are \$265,201,739 a 1.45% increase since June 2018 and a 6.66% increase since December 2018.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2018.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$4,141, and unrealized gains were \$17,286,319, for a total gain of \$17,290,460.

Operating Fund

Total revenue was \$64,230 more than the budget, and total expenses were \$62,553 less than the budget, unrealized gains were \$41,687 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating surplus is \$48,845 compared to a budgeted deficit of \$119,437.

Note: The Expendable Operating Cash-on-Hand is at 6.0 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 6/30/2019 was \$190,122,366. The one-year Total Return for the Long-Term Endowment Portfolio was 4.4% compared to the Policy Index of 5.3%.

The market value of the Medium-Term Fund portfolio at 6/30/2019 was \$7,317,259. The one-year Total Return for the Long-Term Endowment Portfolio was 6.0% compared to the Policy Index of 7.0%.

The market value of the ESG Fund portfolio at 6/30/2019 was \$3,665,158. The one-year Total Return for the Long-Term Endowment Portfolio was 6.2% compared to the Policy Index of 7.0%.

The market value of the DRIM Fund portfolio at 6/30/2019 was \$2,813,441. The Total Return for the DRIM Portfolio, since inception, was 1.1% compared to the Policy Index of -12.7%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking

among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Assets

Total Assets through 7/31/2019 are \$266,316,505 a .42% increase since July 2018 and a 7.11% increase since December 2018.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2018. In July, Stephen and Barbara Brooks established a charitable remainder annuity trust with stock and a house in Carmel valued at \$1,229,790, and a calculated remainder value of \$644,422.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$4,439, and unrealized gains were \$17,897,762, for a total gain of \$17,902,201.

Operating Fund

Total revenue was \$132,352 more than the budget, and total expenses were \$73,522 less than the budget, unrealized gains were \$43,249 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$115,434 compared to a budgeted deficit of \$364,336.

Note: The Expendable Operating Cash-on-Hand is at 5.3 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 7/31/2019 was \$191,849,487. The one-year Total Return for the Long-Term Endowment Portfolio was 2.7% compared to the Policy Index of 4.1%.

The market value of the Medium-Term Fund portfolio at 7/31/2019 was \$7,314,956. The one-year Total Return for the Long-Term Endowment Portfolio was 5.3% compared to the Policy Index of 6.1%.

The market value of the ESG Fund portfolio at 7/31/2019 was \$3,670,990. The one-year Total Return for the Long-Term Endowment Portfolio was 4.7% compared to the Policy Index of 5.4%.

The market value of the DRIM Fund portfolio at 7/31/2019 was \$2,832,490. The Total Return for the DRIM Portfolio, since inception, was 4.5% compared to the Policy Index of -6.2%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the

Development Executive Network, to be used for professional development for people new to the fundraising field, and networking among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$383,402 and total expenses were \$5,733,774, which includes grants totaling \$5,295,709 from the 2018 Monterey County Gives campaign.






Mid-term Fund







Community Foundation for Monterey County Advocacy and Public Policy Guidelines June 2019 (Draft 2)

Introduction

Section 3 (Community Leadership) of the 2015 CFMC Strategic Plan states the following:

Grow the CFMC's profile in advocacy when such activity can create a strong environment for the CFMC to prosper, or support initiatives that align with the CFMC's core values. This may be accomplished through participation in the League of California Community Foundations public policy work, working with the Council on Foundations or other national lobbying groups, partnering with local organizations or, when appropriate, developing our own initiatives.

The definition of advocacy is "public support for or recommendation of a particular cause or policy." The definition of lobbying is "seek to influence (a politician or public official) on an issue." These terms are often used interchangeably, but there is a clear difference between the two. However, for the purpose of these guidelines these definitions will not be used individually; rather, unless specified, they'll be conflated into "advocacy."

IRS codes pertaining to advocacy do not differentiate community foundations from other public charities. However, these guidelines will use "community foundations" rather than "public charities" in order to reinforce that we are referring to allowed/disallowed activities for the CFMC.

The following guidelines outline the methods, parameters and limitations of how community foundations may engage in advocacy work. On the whole, this is not new work for the CFMC, but it has never been guided by a board approved set of guidelines. One can logically anticipate increased advocacy activity for the CFMC, as regulatory threats to philanthropy may become more common. Additionally, in California, increasing usage of the initiative and referendum process also means voters are assuming more responsibility in deciding important policy and fiscal matters, and it will become increasingly likely the CFMC will be asked to provide support on voting initiatives which align with the CFMC's priorities and values. Locally, whether voting initiatives such as bond referendums or lobbying for or against County or local policy decisions, the voice and stature of the CFMC may be sought. It is important that the CMFC determine the circumstances in which it will engage on these matters. Lastly, advocacy work doesn't necessarily equate to influencing legislation or taking positions on public referendums. It can also involve educating public officials on the intricacies and nuances of community issues.

For community foundations with a history of involvement in this arena, advocacy is seen as an integral part of their philanthropic strategy. Such support typically covers a range of activities, from defining the problem(s) and framing key issues to research, analysis and advocacy of specific policy actions. For

others, foundation involvement goes beyond grantmaking to encompass institutional leadership on issues that impact their core mission. This is especially important in a region as large as Monterey County, where the multiplicity of jurisdictions can diffuse leadership on issues that affect the entire County. There may be times when the CFMC can help shape public opinion and provide much needed leadership on significant public policy issues.

Precedence exists with other community foundations which have assumed this mantle of public leadership. The Silicon Valley Community Foundation led a legislative initiative to curb predatory payday lending. The California Community Foundation (Los Angeles) has been part of a public/private effort to make a dent in chronic homelessness. Smaller community foundations across California have been leaders in immigration policy and affordable housing. In the area homeless services, the CFMC led a series of meetings that led to structural changes of the Leadership Council (a HUD mandated group that oversees state and federal funding) and convinced jurisdictions and nonprofits to collaborate on projects. Advocacy, even to public entities, does not always involve shaping legislation.

The following guidelines are a framework for the CFMC's decision-making process on institutional leadership on advocacy. The intent is to define the parameters and develop a process that will enable CFMC staff and board to consider the circumstances in which an institutional position would add value to public discourse or shape legislation.

The Parameters

Who can engage in advocacy. All nonprofit organizations, including public charities like the CFMC and, to a limited extent, private foundations, can participate in public policy development and advocacy.

Definition of advocacy. Advocacy is a broad term that encompasses a range of activities designed to educate and influence others through issue analysis, community organizing and relationship-building. Lobbying is just one of many activities in the advocacy spectrum, which includes the following—

- Educating the public (e.g., through informational brochures, flyers, organizing of rallies);
- Educating legislators (e.g., oral/written testimony);
- Researching and analyzing public policy issues;
- Writing letters/email and sending them to partner organizations, public or elected officials;
- Writing and submitting op-ed pieces or letters to the editor of newspapers and other media outlets;
- Convening meetings, community forums, funder briefings;
- Convening and/or participating in press conferences;
- Voter education;
- Developing relationships with legislators;
- Providing testimony at public hearings and meetings;
- Providing technical assistance or guidance to legislators;
- Training nonprofits on how to engage in grassroots advocacy activities;

- Submitting comments on proposed regulations;
- Supporting candidates for public office (not allowed for 501(c)(3) organizations);
- Supporting/opposing specific initiatives or bond measures;
- Lobbying

Definition of lobbying. Under the laws applicable to community foundations and other public charities, there are two types of lobbying—direct and grassroots.

a. Direct lobbying consists of opinions or actions that are directed at legislators or legislative bodies intended to influence the outcome of a specific piece of legislation. "Legislator" refers to executive level public officials who participate in the development of legislation (this includes senior legislative staff). Under this definition, members of special purpose boards, such as school boards, planning and zoning commissions, are excluded because their functions are narrowly prescribed, and their role is to interpret or implement existing laws. "Specific legislation" includes existing bills that have been assigned a name and a number, as well as legislative proposals that have not been fully developed, are not yet written and not yet introduced.

Exceptions to the definition of "specific legislation" are:

- rules and regulations;
- (2) enforcement (or lack of enforcement) of existing laws and regulations;
- (3) executive orders from a mayor, governor, or president of the U.S.; and
- (4) pending lawsuits

Community foundations are free to comment or advocate on issues involving any of the exceptions listed above. For example, they can participate as parties to a lawsuit or as "friends of the court" in legal briefs supporting or opposing specific litigation. They can write letters to public officials asking for the enforcement of habitability codes or fair housing laws against landlords who violate these provisions. Community foundation support of nonprofits to engage in these activities is not considered lobbying; and community foundations themselves can participate in these activities.

b. Grassroots lobbying includes communications to the public that expresses a point of view about a particular bill or legislative proposal and asks the public to contact their elected representatives in order to influence their vote on a bill or proposal. Direct calls to action will be treated as grassroots lobbying. An example of a direct call to action would be for the CFMC utilize Facebook to urge readers to call their legislators to oppose or support a piece of legislation.

Exceptions to lobbying. There are four exceptions to the statutory definition of lobbying: (1) nonpartisan research and analysis; (2) discussion and analysis of broad social and economic issues; (3) legislative requests for technical advice or assistance; and (4) self-defense. Community foundations can engage in these exempt activities.

- 1. Nonpartisan research and analysis. The research or study should present a balanced, complete explanation of the issue that would enable a reader to reach his/her own independent conclusion. It can advocate a particular position or express a point of view as long as the analysis is evenhanded. The report should be widely distributed, not just shared with recipients who agree with the recommendations. And it should not direct readers to contact their elected representatives. Examples of nonpartisan research are the CFMC's *Status of Women and Girls in Monterey County* and studies produced by nonprofits like the Public Policy Institute of California and the California Budget Project.
- 2. Discussion of broad social and economic issues. Community foundations can convene meetings or community forums to discuss policy issues with government officials and the general public. For example, convenings organized by the CFMC on homelessness and how public and nonprofit agencies can work in a more coordinated fashion led to structural changes in oversight and implementation of public funds. It would be lobbying if the discussions revolved around support or opposition for specific legislation, such as seeking more State funding for homelessness or affordable housing or opposing legislation that reduced funding.
- **3.** Legislative requests for technical advice or assistance. If a legislative or governmental body submits a written request to a community foundation to provide testimony on a particular subject, preparation and presentation of the information are not considered to be lobbying; and the expenses associated with preparing the testimony (e.g., research, writing, production of materials, travel time and costs) are not lobbying expenses. For example, the Assembly Committee on Human Services may send a written request to nonprofit job training providers, asking them to present testimony on the potential effects of federal budget cuts and policy changes affecting state-run welfare-to-work programs. Responding to these written requests is permissible, and the time invested to draft testimony or provide technical assistance is an exempt activity.
- 4. Self-defense. Communications with a legislator or legislative body regarding a bill or proposal that would affect an organization's existence, powers, tax-exempt status, or tax-deductibility of contributions to the nonprofit is not lobbying. For example, AB1712 in the 2019 California legislature sought to require all donor advised fund sponsors to have active funds policies, submit fund-by-fund reporting to the State Attorney General, and left open any action the AG's office might take if funds didn't adhere to an unspecified reporting outcome. The League of California Community Foundations' actions to make this a two-year bill in hopes of satisfactorily modifying or killing the bill was a position of self-defense, as the bill would have altered the business model of its member community foundations. The CFMC's CEO engaged in self-defense activities on behalf of the League of California Community Foundations. It would have been permissible for the CFMC's CEO speak specifically on behalf of a formalized CFMC position. This would not have been considered lobbying, and any expenses incurred in this activity would not have to be reported as lobbying expenses.

Extent of permissible lobbying. Internal Revenue Service regulations allow community foundations to engage in some lobbying. Community foundations can support educational activities and advocacy

through grantmaking and direct institutional engagement. One of two tests is used to determine the permissible amount of lobbying: the "insubstantial part" test or the "expenditure" test.

a. Insubstantial part test. Under this test, lobbying activities should comprise an "insubstantial" part of an organization's overall activities. While "insubstantial" is not clearly defined by the Internal Revenue Service, the parameters are generally set at less than five percent of an organization's total activities.

b. 501(h) expenditure test. Community foundations can elect to be governed under Section 501(h), which permits lobbying up to a certain percentage of their budget. The expenditure limit is generally 20 percent of "exempt purpose expenditures" (often thought of as program budget expenditures within a fiscal year) for all lobbying, of which a quarter of that amount can be spent on grassroots lobbying. In no case can a public charity that has taken the 501(h) election exceed \$1 million a year in lobbying expenses. Application of the test means that a maximum of \$250,000 can be spent on grassroots lobbying, while the remaining \$750,000 can be used for direct lobbying. Community foundations that choose the expenditure test must report their lobbying expenses separately on the IRS Form 990. Some nonprofit organizations that do significant amounts of lobbying may choose to form a separate entity, such as a 501(c)(4) social welfare group or a 501(c)(6) membership association, instead of electing the 501(h) expenditure provision.

Review and Approval Process

Institutional positions. When the CFMC identifies a public policy matter on which it may choose to take a position, or if a request is made to the CFMC to take a position, the following will be considered:

- 1. The matter furthers the Foundation's mission and has a significant impact on residents or communities in Monterey County (e.g., housing, education, access to healthcare, etc.)
- The matter has the potential impact the CFMC's business model or interfere with or create barriers for donors to participate in community philanthropy through a partnership with the CFMC;
- 3. The matter has a direct bearing on the CFMC's programmatic priorities in education, healthcare, neighborhood revitalization or arts and community development; or
- 4. The matter has received affirmative endorsements from two or more key nonprofit, public or private institutional stakeholders that have participated in the policy discussions and/or helped shape the recommendations and proposed actions;
- 5. Taking a policy position would further the goals and objectives in the CFMC's strategic plan; and
- 6. The CFMC has the potential to impact the matter because--
 - the staff has ample knowledge and expertise on the issue;
 - it has the relationships and partnerships necessary to be credible and proactive in the policy community; and

• financial support can be secured through the CFMC's own grantmaking funds and/or through solicitation of other donors and/or institutional funders.

Senior management staff and the president/CEO will thoroughly review the matter presented and assess the implications for the CFMC and potential impact on the public policy debate.

Timing and procedures. If time is of the essence and the issue cannot wait for a regularly scheduled board meeting, the president/CEO will consult with the board chair and executive committee members and request a special meeting of the executive committee by conference call to discuss and potentially vote on the matter. If timing is not critical, the issue will be placed on the agenda for a regularly scheduled board meeting. As with all matters put before the executive committee and the board, approval requires a quorum of members and majority of yes votes.

Implementation

If the board or executive committee determines that an institutional position is warranted, the Foundation's senior management will present recommendations on how that position can be implemented. This can include any or all of the following options:

- attach its name to materials endorsing the initiative;
- provide a public policy grant to a nonprofit or consortium of nonprofits that will work on the issue;
- develop a communications strategy, in collaboration with other stakeholders, to increase public visibility of the issue (e.g. writing op-ed articles, letters to the editor, assisting with press events, etc.)
- implement a variety of civic engagement strategies which may include convenings, forums, briefings and other activities;
- create and/or fund public policy publications, including white papers, issue briefs, and other research and analytical tools to inform and impact the policy debate; and/or
- train nonprofit organizations in public policy and media advocacy.

The specific recommendations will be tailored to each issue. This list of recommended actions is not intended to be exhaustive, but rather, is illustrative of the strategies that the CFMC can consider.
