Assets

Total Assets through 8/31/2019 are \$266,591,806 a .77% increase since August 2018 and a 7.22% increase since December 2018. (p. 4)

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2018. In August, there was an addition to the Evelyn Torras CRT with the contribution of a house in Carmel Valley valued at \$1,375,000, and a calculated remainder value to the CFMC of \$274,817. Other remainder beneficiaries include Montage, Salvation Army and Meals on Wheels. Evelyn's two brothers are the beneficiaries of the CRT. (p. 4)

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$3,005, and unrealized gains were \$16,200,872, for a total gain of \$16,197,867. (p. 6)

Operating Fund

Total revenue was \$147,192 more than the budget, and total expenses were \$66,276 less than the budget, unrealized gains were \$44,949 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$311,537 compared to a budgeted deficit of \$569,703. (p. 7)

Note: The Expendable Operating Cash-on-Hand is at 4.3 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000. (p. 8)

Portfolio Performance

The market value of the Long-Term Fund portfolio at 8/31/2019 was \$191,254,359. The one-year Total Return for the Long-Term Endowment Portfolio was 1.2% compared to the Policy Index of 2.5%. (p. 9-11)

The market value of the Medium-Term Fund portfolio at 8/31/2019 was \$7,307,083. The one-year Total Return for the Long-Term Endowment Portfolio was 5.2% compared to the Policy Index of 6.0%. (p. 12-13)

The market value of the ESG Fund portfolio at 8/31/2019 was \$3,678,773. The one-year Total Return for the Long-Term Endowment Portfolio was 3.8% compared to the Policy Index of 4.0%. (p. 14-15)

The market value of the DRIM Fund portfolio at 8/31/2019 was \$2,780,271. The one-year Total Return for the DRIM Portfolio was 4.7% compared to the Policy Index of -7.7%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting. (p. 16-17)

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking

among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$383,421 and total expenses were \$5,770,214, which includes grants totaling \$5,295,709 from the 2018 Monterey County Gives campaign. (p. 5-6)
