CALL TO ORDER

Board chair Birt Johnson, Jr. called the regular meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:37 PM, Tuesday, August 27, 2019 at the Foundation's Monterey office.

CONSENT AGENDA – Birt Johnson, Jr.

Birt Johnson asked the board if they had any questions or required clarification on matters related to the consent agenda. There were no questions or concerns.

Betsy Buchalter Adler / Ida Lopez Chan, second. Motion carried unanimously.

Not on the agenda:

Real Estate Committee update on 3200 17 Mile Drive Offer to Purchase

Dan Baldwin introduced, Jim Heisinger, real estate attorney and member of the real estate committee. The 3200 17 Mile Drive work group is made up of Bill Mitchell, Teri Belli, Birt Johnson and Dan Baldwin who are authorized to negotiate on the offers received from purchasers.

Dan reviewed the history of the acceptance of the Charles deGuigne gift of real estate from 2017. Dan summarized the activity of offers over the past year.

The CFMC has an offer on the property that has elements that the board needs to be aware of.

The current offer:

- \$22 million purchase price
 - \$12 million down payment
 - Seller finances \$10 million
 - Five years
 - 2% per year
 - Paid annually
 - 30 day grace period for late payments
 - 5% penalty for late payments after grace period
- \$100,000 deposit upon agreement of terms; additional \$100,000 upon removal of lifting contingencies
- 45 contingency
- 75 day close
- CLTA paid by seller

Birt, Dan and Jim Heisinger led a discussion on the details of the counter offer that the CFMC real estate committee crafted, how the purchaser was vetted and options for negotiating the most advantageous fund balance and interest rates. After a thorough discussion about the risks, the question was asked whether the board would consider giving the real estate committee the flexibility to negotiate this offer or others that include a self-financing component, by the CFMC.

Motion: to allow flexibility for the CFMC real estate committee to negotiate valid real estate offers on the purchase of 3200 17 Mile Drive that include self-financing components.
Jose Luis Alvarado / Betsy Buchalter Adler second. Motion carried unanimously.

REPORT OF THE CHAIR – Birt Johnson, Jr.

Birt Johnson reflected on the passing of former board member and community leader, Breck Tostivin.

Birt reminded the board of the 2019 Celebration of Philanthropy, which will be October 30 at Corral de Tierra. He encouraged the board to attend and discussed the importance of being an ambassador including bringing friends who may not be familiar with the CFMC. The Honorable Lydia Villareal will receive the Distinguished Trustee Award.

Jeff Eikenberry, CFMC secretary (corrected), is moving out of the area and will be resigning from the board as of the August 27, 2019 meeting. Birt gave Jeff many thanks for his commitment to the CFMC board leadership.

TREASURER/FINANCE COMMITTEE – Jan Vanderbilt

Jan reviewed the July 31, 2019 financials. She highlighted total new contributions and change in net assets for June and July. Jan reviewed the operating revenue/expenses versus budget. She highlighted the 5.3-month cash reserve as a healthy safety net.

Motion: to approve the Financial Statements for June 30, 2019 and July 31, 2019.
Abby Taylor-Silva / Bill Mitchell, second. Motion carried unanimously.

Diane Nonella reported the 2020 budget process is on track with round two of the draft in motion. The finance committee will review the proposed budget in October (and November if needed) and present the final version to the board for approval at the December meeting.

GRANTS AND PROGRAMS – Ida Lopez Chan

Ida Lopez Chan requested approval of the June 30, 2019-July 31, 2019. There are 470 grants totaling \$2,615,593.

Motion: to approve 470 grants awarded from June 30, 2019 - July 31, 2019, totaling \$2,615,593. Betsy Buchalter Adler / Erika Padilla-Chavez, second. Motion carried unanimously.

Motion: to approve 7 donor advised grants over \$50,000 totaling \$566,000 to the Pacific Grove Public Library Fund for the Future (\$60,000 and \$56,000), Boys & Girls Clubs of Monterey County(\$100,000), Food Bank of Monterey County (\$100,000), Planned Parenthood Mar Monte (\$50,000), Rancho Cielo (\$100,000) and Veterans Transition Center (\$100,000). Ida Lopez Chan / Maija West second. Motion carried unanimously.

Michael Castro, Program and Scholarships Officer, presented an update on 2019 scholarships. He reported on scholarship growth, the College Futures collaboration and how the students apply on line. CFMC has awarded 363 scholarships for \$1.4 million in 2019.

INVESTMENT COMMITTEE – Ken Petersen

Ken Petersen reviewed the 7/31/2019 portfolio overview and market value of the Long-term fund, Mid-term fund, and the ESG fund. He described the benefits of diversification in a volatile market.

The revised Investment Policy Statement will be recommended for approval at the December board meeting.

GOVERNANCE COMMITTEE – Ken Petersen

Ken reported the committee met to discuss the replacement for Jeff Eikenberry as secretary, and recommends Maija West.

The committee will review the nominations for 2020 board and report at the October board meeting.

NEW FUNDS – Dan Baldwin

Dan sought approval to convert three donor advised funds from endowed to non-endowed funds. The request was made by Bertie Elliott, who is the sole donor on all three funds

Ken Petersen / Ida Lopez Chan second. Motion carried unanimously.

Amelia Craig, Co-Trustee with Hanson Reed of the RUDOLPH E. FUTER REVOCABLE TRUST, has resigned. The CFMC will act as co-trustee of the Futer Revocable Trust handling the miniature horse estate.

Motion: to accept the co-trusteeship of the Rudy Futer Revocable Trust to the Community Foundation for Monterey County.

Ida Lopez Chan / Elsa Jimenez Mendoza second. Motion carried unanimously.

Dan described the 2019 Charitable Gift Annuity set up by Robert Haas that requires approval by the board.

Motion: to approve the August 2019 Robert Haas Charitable Gift Annuity for \$60,000.

Betsy Buchalter Adler /Teri Belli second. Motion carried unanimously.

PRESIDENT'S REPORT – Dan Baldwin

Dan sent an electronic report to the board prior to the meeting.

The CFMC will celebrate its 75th Anniversary in 2020, culminating at the Celebration of Philanthropy. An advisory committee will be set up with staff, current and past board members to set the direction of the celebration (Teri Belli has volunteered). Dan asked any interested board members to contact Christine Dawson or Amanda Holder.

The presentation on the *Misconceptions of the CFMC*, by Christine Dawson was postponed for a future meeting.

Dan presented a PowerPoint on the Advocacy Guidelines. The guidelines create a framework for how the CFMC will engage in lobbying or advocacy work. Dan described the parameters, review and approval process and outlines of the law that defines nonprofit advocacy.

The board agreed to the adopt the guidelines as presented.

The board went into Executive Session at 5:35 PM.

Birt Johnson called the regular meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:34 on September 24, 2019 at the Foundation's Monterey office. Birt welcomed Maija West to the committee as the treasurer, replacing Jeff Eikenberry.

REPORT OF THE CHAIR – Birt Johnson, Jr.

Birt encouraged the board to attend the Celebration of Philanthropy, October 30, 2019 at Corral de Tierra County Club. The Honorable Lydia Villareal has agreed to receive the Distinguished Trustee Award.

The committee discussed their schedules for the Thanksgiving holiday week and agreed to keep the November 26 date for the next executive committee meeting.

TREASURERS REPORT – Jan Vanderbilt

Jan Vanderbilt reported the August and September financial statements will be reviewed and approved at the October board meeting. She reviewed the August 31 financials and reported the operating fund is still under budget.

RESOURCE DEVELOPMENT– Michael Reid

Michael Reid highlighted the events and activities the philanthropic services team are involved in. A subcommittee has been created to work on the myths and misconceptions of CFMC in the community. They are developing a PowerPoint to present at the October board meeting.

Christine Dawson summarized the launch of the 2019 Monterey County Gives! campaign, which has 162 nonprofit organizations participating. November 7 is the opening day of the campaign.

On October 10, Anne Westreich of Verus and Dan Baldwin will do investment briefings for donors and nonprofit agencies. They will discuss portfolio performance, investment policy and strategy.

The community members interested in forming a Carmel Valley Affiliate Fund met at Holman Ranch for an educational overview. The Big Sur community is exploring an affiliate fund as well.

GRANTS AND PROGRAMS COMMITTEE – Ida Lopez Chan

Ida Lopez Chan recommended approval of the donor advised, interfund transfers and other grants over \$50,000.

Dan reported the committee's next meeting is November 4, when the revised 2019 Investment Policy Statement will be finalized. Gif Lehman, Steve Dart, Anne Westreich, Ken Petersen and Dan Baldwin have been preparing the new draft. It will go before to the board in December for approval.

Dan reported the committee will review the nominations for the 2020 board and bring recommendations to the October board meeting.

Michael Reid asked a question about opportunities for youth in philanthropy as potential board nominees. Maija West noted there are future youth leaders coming up through the Women's Fund Scholarships.

COMMUNITY IMPACT INVESTMENT COMMITTEE – Nolan Kennedy

Nolan reported the committee is assessing an assortment of countywide projects. They will continue to discuss the opportunities, risks and outcomes of the impact investing collaborations presented to them.

PRESIDENT/CEO REPORT - Dan Baldwin

3200 17 Mile Drive

The 3200/3204 17 Mile Drive property is in escrow with a \$21 million cash offer. There is also a backup offer.

The committee has submitted a claim for refund of property taxes with the county Board of Supervisors. The claim is for consideration of an exempt nonprofit property tax status during the period the CFMC has owned the property. They are waiting for a response and will consider next steps once the status of the claim is known.

Other Real Estate

The Brooks CRT is complete and the property sold in Carmel by the Sea.

The Evelyn Torres Unitrust has added a residence which will go on the market in mid-October or November.

The trust is being established for the Ruh's property in Los Gatos. They hope to transfer the title by November 1, then the property will go on the market.

The CFMC 75th Anniversary

An Advisory committee was formed and met September 23 to discuss the direction for the 75th Anniversary occurring in 2020. Amanda Holder reviewed some historic research and ideas for a variety of activities. The group agreed a sit-down dinner in place of the Celebration of Philanthropy reception was a good idea. The staff will reach out to venues capable of holding 300-500 people, as well as sponsors to offset the expenses.

Sherrie McCullough suggested the CFMC embrace the local non-profits as partners and highlight how we work together for the community. The committee will meet in January 2020 to expand on ideas.

2020 Census

The CFMC will utilize funds provided by the State of CA to the County of Monterey to hire three local consultants. These consultants will work with community groups under the CFMC's guidance to help CFMC with our Census 2020 grantmaking process – including the re-granting process of \$240,000 to Monterey County organizations that represent the hard to count populations.

The CFMC is taking a leadership role in making sure the census count for Monterey County is as complete as possible.

Item not on the Agenda

The board has decided to do a board self-assessment. A sub-committee (Ida Lopez Chan, Nolan Kennedy, and Maija West) are working on drafting the survey. The intent is to get feedback from the board about how things are going, improvements, board orientation and culture. Do they feel engaged? The goal is to have the results by the December board meeting.

Meeting adjourned at 5:00. There was no executive session.

Kaki Rusmore and Susie Polnaszek provided an overview and update of the Center for Nonprofit Excellence (CNE), including updates of the recently completed Next Steps for Small Nonprofits program, which utilized a "wrap-around" model CFMC has found to be successful for nine grantees with budgets under \$200,000. The model includes:

- Multi-year, general operating grants
- Coach/mentor consultants
- Peer learning/convenings
- Training
- Access to Organizational Development grants

Highlights of the evaluation of the three-year Next Steps program include:

a) Leadership

- Larger, more engaged & prepared boards
- Executive Directors more confident leaders
- Stronger problem-solving skills
- Greater use of best practices, innovation
- Stronger leadership built stronger nonprofits

b) Financial Management/Fundraising

- Three-year grants gave stability, time to develop systems
- Increased budgets, diversified funding streams
- Better budgets, financial systems, reporting
- Working well with financial professionals
- Greater stability, strategic financial management

c) Communication

- Increased visibility in community
- More speaking engagements, one-on-ones
- Greater, more effective use of social media
- New materials, marketing committees
- Stronger relations with community partners

d) Programs

- New, expanded programming
- Increases in staffing & volunteers
- Stronger assessment & evaluation
- Improved program quality
- Greater cultural competency

Committee members suggested sharing the evaluation results with the Board and agreed that the concept of the CFMC/CNE implementing another, similar program is worthwhile to consider. Tentative thoughts are to provide a program for a specific field, location or group, based on community needs or nonprofit type.

3. Re-envisioning the Community Impact (CI) Program

Laurel reviewed the timeline and programmatic revisions for the CI program in 2020 agreed upon at the August 2019 committee meeting. The staff led a review of “Giving Together,” CFMC’s co-investment program for Donor Advisors, including a history of total co-investment since the program began in 2013.

The committee agreed there is opportunity to expand and enhance the Giving Together program and support the idea to provide education to the Donor Advisors who have supported specific grant applicants through Giving Together to find ways to maximize giving and “stretch” CFMC’s CI grantmaking funds to consider multi-year/recurring grants.

Assets

Total Assets through 8/31/2019 are \$266,591,806 a .77% increase since August 2018 and a 7.22% increase since December 2018.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2018. In August, there was an addition to the Evelyn Torras CRT with the contribution of a house in Carmel Valley valued at \$1,375,000, and a calculated remainder value to the CFMC of \$274,817. Other remainder beneficiaries include Montage, Salvation Army and Meals on Wheels. Evelyn's two brothers are the beneficiaries of the CRT.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$3,005, and unrealized gains were \$16,200,872, for a total gain of \$16,197,867.

Operating Fund

Total revenue was \$147,192 more than the budget, and total expenses were \$66,276 less than the budget, unrealized gains were \$44,949 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$311,537 compared to a budgeted deficit of \$569,703.

Note: The Expendable Operating Cash-on-Hand is at 4.3 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 8/31/2019 was \$191,254,359. The one-year Total Return for the Long-Term Endowment Portfolio was 1.2% compared to the Policy Index of 2.5%.

The market value of the Medium-Term Fund portfolio at 8/31/2019 was \$7,307,083. The one-year Total Return for the Long-Term Endowment Portfolio was 5.2% compared to the Policy Index of 6.0%.

The market value of the ESG Fund portfolio at 8/31/2019 was \$3,678,773. The one-year Total Return for the Long-Term Endowment Portfolio was 3.8% compared to the Policy Index of 4.0%.

The market value of the DRIM Fund portfolio at 8/31/2019 was \$2,780,271. The one-year Total Return for the DRIM Portfolio was 4.7% compared to the Policy Index of -7.7%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking

among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$383,421 and total expenses were \$5,770,214, which includes grants totaling \$5,295,709 from the 2018 Monterey County Gives campaign.

Total Assets through 9/30/2019 are \$270,357,341 a 2.91% increase since September 2018 and an 8.73% increase since December 2018.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2018. In September, William Donovan established a \$100,000 CGA for the benefit of his son Jason. The CGA is deferred and will make its first distribution in 2030. The remainder value is calculated at \$69,776 and will establish the Jason A. Donovan Charitable Fund.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$12,579, and unrealized gains were \$17,343,316, for a total gain of \$17,355,895.

Operating Fund

Total revenue was \$93,033 more than the budget, and total expenses were \$72,075 less than the budget, unrealized gains were \$45,540 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating surplus is \$133,580 compared to a budgeted deficit of \$76,785.

Note: The Expendable Operating Cash-on-Hand is at 6.3 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 9/30/2019 was \$193,970,892. The one-year Total Return for the Long-Term Endowment Portfolio was 2.4% compared to the Policy Index of 3.8%.

The market value of the Medium-Term Fund portfolio at 9/30/2019 was \$7,325,219. The one-year Total Return for the Long-Term Endowment Portfolio was 5.8% compared to the Policy Index of 6.7%.

The market value of the ESG Fund portfolio at 9/30/2019 was \$3,693,741. The one-year Total Return for the Long-Term Endowment Portfolio was 5.0% compared to the Policy Index of 5.1%.

The market value of the DRIM Fund portfolio at 9/30/2019 was \$2,739,332. The one-year Total Return for the DRIM Portfolio 3.4% compared to the Policy Index of -14.9%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include: Pathways to Safety, funded by the ACTION Council of Monterey County; the Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the College Futures Foundation program, funded by the College Futures Foundation; the Monterey County Development Professionals, funded with the remaining assets from the dissolution of the Development Executive Network, to be used for professional development for people new to the fundraising field, and networking

among those involved in fund development; and the Salinas Leadership project, funded by the James Irvine Foundation; and the Monterey County Gives annual campaign.

In September, we became co-trustee of the Rudy Futer Pony Trust, which was established by Mr. Futer for the care of his miniature ponies. The remaining ponies are Rooster, Rusty, Sable and Trooper. The current value of the trust is \$346,842. When the trust terminates, the remainder will be added to the Rudy E. Futer Fund for Human & Humane Needs.

Total Special Program revenue was \$843,228 and total expenses were \$5,788,704, which includes grants totaling \$5,295,709 from the 2018 Monterey County Gives campaign.

We are filing a Claim Against County of Monterey in the amount of \$535,167.73 for property taxes paid on 3200-3204 17 Mile Drive, Pebble Beach CA.

On the advice of the Monterey County Assessor's office, we are making clear this filing is a claim and not an appeal. This claim is based on the July 11, 2019 Welfare or Veterans' Organization Exemption Assessor's Finding on Qualification of Property Use in which the Monterey County Assessor's Office marked N.E.U. as the requirement not met. N.E.U. states that the "Property is not used exclusively for religious, hospital, or charitable purposes within the meaning of section 214 of the Revenue and Taxation Code."

The Community Foundation for Monterey County ("CFMC") is a public charity described in Sections 501(c)(3) and 509(a)(1) of the Internal Revenue Code. CFMC's specific charitable purpose, as stated in its Articles of Incorporation, is "to receive, distribute and provide funds and services to charitable organizations for the benefit of persons and communities within Monterey County, California." CFMC achieves this charitable purpose mainly by receiving contributions and making grants, thus serving as a bridge between donors and Monterey County charitable programs operated by other organizations.

The Properties are currently owned by the LLC, which, along with its sole member, the CFMC, is organized and operated exclusively for charitable purposes; neither is organized for profit or allows any private inurement; the LLC is using the Properties exclusively for the purpose of liquidating them to
