Erica Padilla-Chavez / Elsa Mendoza second. Motion carried unanimously.

REPORT OF THE CHAIR – Birt Johnson, Jr.

LCCF Chair Meeting

Birt reported he and Teri Belli attended the League of CA Community Foundations (LCCF) Chair Retreat. The topics ranged from homelessness, wildfires, CV19 recovery, food banks and social justice. Birt led a panel discussion on diversity, equity, and inclusion (DEI) and found many community foundations statewide are working on initiatives for 2021.

Schedule of meetings-The 2021 meeting schedule was distributed.

Board Retreat: January 30 9:00AM - 12NOON: Teri Belli

Teri asked for input and agenda items for the retreat. The topics of diversity, equity, and inclusion (DEI), CF 101 and getting to know each other better were discussed. It was agreed that a separate meeting

with a facilitator for a deep dive into DEI would be valuable later in the year. The board will send ideas to Teri and Dan and the agenda will go out one week before the retreat.

Board Member Recognition – Jose Luis Alvarado, Erica Padilla-Chavez, Ida Lopez Chan, Michael Reid

Birt recognized the departing board members with sincere appreciation for their commitment and participation over the terms of their service.

Teri reflected on the 2-year term of service for Birt Johnson as Chair. She recognized his energy, preparation, and thoughtful considerations as a board leader. A short video tribute highlighted Birt and the members work over the years.

TREASURER/FINANCE COMMITTEE - Jan Vanderbilt

Jan reviewed the financial statements for October. She highlighted the special program revenues, total assets, contributions, grants and operating budget expenses and revenues. The changes in the CFMC operations due to the pandemic reduced expenses and the revenues exceeded the budget projections resulting in a surplus.

Motion: to approve the October 31, 2020 financial statements.

Jan Vanderbilt / Kirk Gafill second. Motion carried unanimously.

2021 Budget Approval

Jan reported the 2021 budget was approved by the finance committee. Dan summarized how the fund balances, revenue contributions, administrative fees and expenses are calculated to create the budget numbers. The 2021 budget projects a \$70,481 surplus.

Motion: to approve the 2021 budget as presented.

Jan Vanderbilt /Maija West second. Motion carried unanimously.

INVESTMENT COMMITTEE - Giff Lehman

Giff reported on the spending policy and payout rate for endowed funds for 2021. He reviewed how the decisions are made using historical data to arrive at the committee's recommendation of 4.25% payout rate. This does not apply to the non-endowed donor advised funds.

Motion: to approve the recommended 4.25% payout rate for 2021.

Giff Lehman / Nolan Kennedy second. Motion passed unanimously.

GOVERNANCE COMMITTEE – Betsy Buchalter Adler

Betsy recommended the re-election of Maija West, Jan Vanderbilt, Loren Steck and Abby Taylor-Silva for a second term. They have agreed to serve a second term.

Motion: to approve the second term of Maija West, Jan Vanderbilt, Loren Steck and Abby Taylor-Silva.

Betsy Buchalter Adler / Elsa Mendoza Jimenez second. Motion passed unanimously.

Jennifer Walker, Adriana Melgoza and Romero Jalomo have accepted invitations to join the board in 2021. There is one seat open that will be filled during the year.

Motion: to approve the three selected candidates: Jennifer Walker, Adriana Melgoza and Romero Jalomo to the 2021 board.

Betsy Buchalter Adler / Joe Pezzini second. Motion passed unanimously.

Betsy reviewed the board officers nominated for 2021.

Motion: to approve the 2021 board officers: Chair-Teri Belli, Vice Chair-Betsy Buchalter Adler (1 year term), Secretary-Maija West, Treasurer-Jan Vanderbilt.

Loren Steck / Judy Guzman Kruger second. Motion passed unanimously.

COMMUNITY IMPACT INVESTMENT COMMITTEE - Noian Kennedy

Nolan reported the committee is researching options for next steps on impact investments. The committee expects new opportunities to review in the first quarter of 2021 from the information being gathered and from their association with Community Capital Advisors.

PHILANTHROPIC SERVICES COMMITTEE -Michael Reid

Michael sent words of appreciation out to the staff and board for his experience on the CFMC board.

Christine Dawson reviewed the Resource Development summary for November. She highlighted the growth in contributions and new funds in 2020. Christine reported the MC Gives 2020 is above the 2019 donations amount.

Amanda Holder shared one of the 30 videos created in 2020 for the 75th anniversary celebration. She described how the CFMC pivoted the 75th year celebrations to a virtual format. The videos will leave a legacy for the foundation to share its 75-year history.

COMMUNITY IMPACT COMMMITTEE – Ida Lopez Chan

Ida shared her deep appreciation to the CFMC for all that she learned during her 7-year term.

Ida Lopez Chan requested approval of the October 1 through November 30, 2020 grants. She reviewed the six grants for \$50,000 and over, including the two special project grants from James Irvine Foundation Micro-Loan Fund to El Pajaro Community Development Corporation and California Coastal Rural Development Corporation. The VNA will receive an interfund transfer from their Central Coast VNA and Hospice, Inc. Stewardship Fund for \$817,020.

Motion: to approve 244 grants awarded from October 1 through November 30, 2020 totaling \$4,017,412

Betsey Pearson / Francine Rodd second. Motion carried unanimously.

Ida described the 2020 Community Impact Fall recommendations for approval. The three areas include Environment & Animal Welfare, Arts, Culture and Historic Preservation.

Motion: to approve 37 grants awarded totaling \$971,785

Elsa Mendoza Jimenez / Joe Pezzini second. Motion carried unanimously.

The subcommittee members shared remarks about the experience of working on the CI grants committee during the challenging year of 2020. Birt appreciated the work of Ida as chair and the staff and board members commitment of time to the grant process.

NEW FUNDS - Dan Baldwin

Dan mentioned a new fund not on the agenda, the Barbara Moore and Renee Franken Fund. These are long time community members that have known the CFMC over the years and have circled back to open personal funds.

PRESIDENT'S REPORT - Dan Baldwin

Staffing

Dan described the staffing updates in the President's report.

Covid 19 Initiative

Dan is working closely with Erica Matadamas to harness the wide range of agencies, corporations, hospitals, and business sectors to engage as a group to address the Covid-19 challenges facing the county. The issues include rolling out the vaccine, community education around farmworkers, equity, housing, and trust in the messaging. There is a consultant that will work with CFMC to assist with the facilitation of the initiative. The initiative is expected to play a big part in 2021 convening activities.

Call to Order

Board chair Teri Belli called the ZOOM meeting to order at 9:00 AM, on Saturday, January 30, 2021. Adriana Melgoza, Romero Jalomo and Jennifer Walker were welcomed as new board members. The board and staff introduced themselves to the new members in an icebreaker.

Business Meeting

The business portion of the retreat agenda was carried over to the February 23, 2021 board meeting. There were no action items to approve.

The board received conflict of interest and confidentiality forms to complete and return.

2020 Year in Review

Dan Baldwin went through a PowerPoint presentation that recapped 2020 highlights, accomplishments, and adaptations to the Covid 19 pandemic. The report included a year-end review of the areas of community impact, philanthropic leadership, and organizational excellence. Dan discussed how the CFMC is growing dramatically with a comparison of grants, assets, and contributions from 2010 to 2020 and showed the challenges that growth has presented.

Dan reviewed the organization goals for 2021.

Breakout Group One-Organizational Excellence

The board and staff separated into four small groups. Each group was asked to discuss the *Board Role in Organizational Goals* and the nature of board meetings. After the breakout, each group presented the results of their discussion.

Summary Phrases:

- Breakup meetings into two 45-minute sessions-1 for business action items, 1 for discussion.
- Define discussion topics ahead of time and come prepared. Occasional homework.
- Review an "active listening" training to members.
- Use Zoom polls, breakout rooms, anonymous chat tools and facilitators to engage discussions.
- Board chair can act as moderator to allow time for each topic before moving on.
- Board packets are complex and take time to learn all the facets of CFMC.
- Board should have an active role in future looking initiatives and issues that affect public perception.
- Ask Dan how board can assist in current topics how can CFMC use all the resources available on the board to be active in large initiatives.

Breakout Group Two - Diversity Equity and Inclusion Summary Phrases:

- We need to keep having the discussions and learning.
- There is healing power in philanthropy.
- CFMC can address the causes not just the symptoms.
- CFMC can use its role as convenor to lead these conversations.
- Make investments in early childhood education.
- The board needs tools such as ground rules and agreements that will assist with more open discussions.
- Keep the diversity of the board a priority.
- Keep Zoom as a tool to provide access for people who cannot be at the meeting.
- Duplicate what the CFMC staff has done with a DEI committee for the board.

Minutes

Financial Statement Review

Jan Vanderbilt reviewed the October 2020 financial statement.

The committee discussed the number of months of cash reserves. Dan explained the growth in transactional activity and the potential need for added positions, which are not in the 2021 budget.

On a motion by Teri Belli, seconded by Joe Pezzini, the committee approved the October 2020 financial statement.

2021 Operating Budget

Jan reviewed the final draft of the 2020 operating budget, which shows revenues of \$3,941,451, and expenses of \$3,870,970, for a net surplus of \$70,481. The committee noted that forgiveness of the PPP loan will greatly increase the projected net surplus.

The committee discussed the updates, and at the conclusion on a motion by Jan Vanderbilt, seconded by Joe Pezzini, the committee approved forwarding the budget as presented to the full board for final approval.

Discussion Item

Dan gave a brief year in review and discussed the resource development plan and the processes imbedded in the plan for planned gifts.

Dan next described the recruitment process and our engagement with Robert Half for filling the Director of Finance position.

The regular meeting of the Investment Committee (IC) of the Community Foundation for Monterey County was called to order by Giff Lehman at 3:00 PM on February 8, 2021. The meeting was conducted via Zoom.

Minutes

On a motion by Loren Steck, seconded by Bill Sharpe, the November 9, 2020 minutes were approved as written.

Action Item

Anne raised a question on the allocation decision related to the May 2020 decision to liquidate commodities and not move forward with infrastructure. Her understanding was that the reallocation would be across equity, fixed income, and REITs. That information was confirmed as previously formalized.

<u>Verus</u>

Anne Westreich introduced Joe Abdou, an associate from the San Francisco office of Verus.

Anne presented the Performance Report for the Long Term Portfolio, Medium Term Portfolio, ESG Portfolio, and DRIM. The fourth quarter 2020 investment results were reviewed.

A question related to the how the rank appearing on the Executive Summary is determined. Anne noted that the rankings will rank the individual strategies relative to the individual peer groups. Joe Abdou gave further information on the details of the ranking methodology. Anne stated the Community Foundation has been ranked in the \$50mm - \$250mm group based on net assets. An increase in net assets will move the Foundation to the next rank level in the quarter.

Bill Doolittle raised a question about the YTD Long Term Fund Executive Summary Alternatives 1 Year Return value of -7.4. It was noted that the average of the current returns did not support the return. Anne noted that the average was impacted by a commodities fund that is no longer included in the alternative assets.

YTD Performance

The market value of the Long-Term portfolio at 12/31/2020 was \$281,192,104. The YTD returns were 11.7% compared to the policy benchmark of 11.3%.

The market value of the Medium-Term portfolio at 12/31/2020 was \$8,336,198. The YTD returns were 13.1% compared to the policy benchmark of 10.7%.

The market value of the ESG portfolio at 12/31/2020 was \$4,465,602. The YTD returns were 12.1% compared to the policy benchmark of 12.9%.

Annual Workplan

Anne reviewed the annual work plan and asked the committee if they had any suggestions for changes. Anne asked if it would be helpful to see how allocations compare to other community foundations. The committee felt it would be beneficial and asked that the information be added.

The potential for interim informational meetings was discussed. The committee supported the addition of learning sessions related to investment information to be scheduled between committee meetings.

Philosophies and Decisions

Anne went through the Philosophies and Decisions with the goal of creating a document that provides an overview of the Committee's philosophies and broad decisions. Committee recommendations to content was noted and will be incorporated for review.

DRIM Review

There was a discussion related to the Neumeier Poma Investment Counsel portfolio, fiduciary responsibility and asset allocation policy. As a note of action, it was requested that Dan approach the advisor with a request to align the asset allocation policy with the actual allocation.

COMMUNITY FOUNDATION FOR MONTEREY COUNTY NOTES TO THE FINANCIAL STATEMENTS For the Eleven Months Ended November 30, 2020

<u>Assets</u>

Total Assets through 11/30/2020 are \$331,267,454 an 17.66% increase since November 2019 and a 13.51% increase since December 2019.

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2019.

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$5,514,185, and unrealized gains were \$25,601,087, for a total gain of \$20,086,902.

Operating Fund

Total revenue was \$163,975 more than the budget, and total expenses were \$159,564 less than the budget. Realized and unrealized gains were \$58,788 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$63,934 compared to a budgeted deficit of \$624,357.

Note: The Expendable Operating Cash-on-Hand is at 7.5 months, excluding the operating reserve of \$500,000, the building reserve of \$150,000, and including the PPP Loan of \$411,402, which is expected to be forgiven.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 11/30/2020 was \$270,862,063. The one-year Total Return for the Long-Term Endowment Portfolio was 10.6% compared to the Policy Index of 10.5%.

The market value of the Medium-Term Fund portfolio at 11/30/2020 was \$8,165,612. The one-year Total Return for the Medium-Term Endowment Portfolio was 12.0% compared to the Policy Index of 10.1%.

The market value of the ESG Fund portfolio at 11/30/2020 was \$4,362,075. The one-year Total Return for the ESG Portfolio was 10.9% compared to the Policy Index of 11.8%.

The market value of the DRIM Fund portfolio at 11/30/2020 was \$2,657,295. The one-year Total Return for the DRIM Portfolio was 4.8% compared to the Policy Index of -13.9%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Proposed Fund Allocations for CFMC Grant Programs - 2021

The beginning balance of the Unrestricted (which includes *The Fund for Monterey County*, formerly known as *the General Endowment*) and Field of Interest (FOI) funds available for grantmaking is: \$2,063,305.

- a) Total available from FOI funds: \$1,643,085
- b) Total available from Unrestricted funds (including \$317,547 from *The Fund for Monterey County*): \$420,220

After the following disbursements totaling \$200,500 are allocated from the Unrestricted funds, **\$1,862,805** is available for the Community Impact (CI) grantmaking program.

1. \$200,500:

- a) \$150,000 for the Opportunity Fund:
 - \$100,000 for Opportunity and Organizational Development grants to support small grants (typically \$5,000 or less) for organizational development, emerging ventures and urgent needs.
 - \$50,000 for CEO Discretionary Grants for CFMC grants to support timesensitive needs.
- b) \$5,000 to support Leadership for Community Transformation, a collaborative community leadership training program for Monterey County (third year of a four-year grant). Note: the CFMC commitment is \$10,000/year: \$5,000 will be from CNE (Packard Foundation grant).
- c) \$15,500 for various grants (MC Gives! awards and match: \$14,500; Philanthropy Day awards: \$1,000).
- d) \$10,000 for CFMC Employee Matching Gift program (\$500 allocated for each of 20 employees).
- e) \$10,000 CFMC's annual Distinguished Trustee award grant.
- f) \$10,000 for 2020 Neighborhood Grants that were deferred to 2021. Note: Every year, we allocate \$50,000 to the Neighborhood Grants Program (NGP) for small grants to grassroots, mostly voluntary associations of neighborhood residents coming together around community improvement efforts. For 2021, NGP is "on pause" due to the pandemic.
