Vice Chair Kirk Gafill called the meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:32 p.m., Tuesday, August 23, 2022.

Motion: To approve the Consent Agenda as presented. Loren Steck / Larry Oda second. Motion carried unanimously.

REPORT OF THE CHAIR - Kirk Gafill

Vice Chair Gafill referenced the president's report in regard to the National Standards accreditation and applauded the work of the staff.

Vice Chair Gafill solicited directors' feedback on meeting logistics. The options being all on zoom, all in-person or a balance of a few in-person meetings with the rest on zoom. The suggestion for an in-person December holiday board meeting was discussed. Due to the changing environment, the consensus was to continue zoom meetings and revisit the discussion after the Monterey conference room technology upgrade.

TREASURER / FINANCE COMMITTEE - Jan Vanderbilt

Treasurer Jan Vanderbilt presented the financial statements for June 30, 2022 and July 31, 2022. She reiterated the variances are attributed to the volatility of the current market.

Motion: To approve the June/July 2022 financials as presented.

Jan Vanderbilt / Francine Rodd second. Motion carried unanimously.

Treasurer Vanderbilt asked if there were any questions regarding the 2021 990 that was on the board portal for review. Following a brief discussion, the finance committee recommended accepting the 990.

Motion: To accept the 2021 990 as presented. Loren Steck / Joe Pezzini second. Motion carried unanimously.

Treasurer Vanderbilt announced the 2023 CFMC budget process has started internally with the CFMC staff and will be presented for review to the finance committee in the 4th quarter. The final presentation and approval from the board of directors will be at the December board meeting.

GOVERNANCE COMMITTEE – Elsa Jimenez

Board member Elsa Jimenez reported the committee's nominating priorities to fill the four board vacancies in 2023. They will be reviewing the board member job descriptions and CFMC bylaws by year end.

COMMUNITY IMPACT INVESTMENT COMMITTEE – Nolan Kennedy

Board member Nolan Kennedy reported that the United Way loan has been funded. It supports the purchase of their building in Salinas. The committee was approached by Sun Street Center about a loan proposal to build a new building on their land. A term sheet has been provided to Sun Street Center. Board discussion followed.

INVESTMENT COMMITTEE - Giff Lehman

Board member Giff Lehman gave an update on the performance of the CFMC's investment portfolios.

COMMUNITY IMPACT – Adriana Melgoza

Board member Adriana Melgoza presented to the board two items for approval.

The grant approvals for June 1, 2022, to July 31, 2022.

Motion: To ratify 484 grants for a total of \$7,634,435.64 from June 1, 2022 – July 31, 2022. Joe Pezzini / Tyller Williamson second. Motion carried unanimously.

Board member Melgoza asked President Dan Baldwin to explain the process and reasoning for the dissolution withdrawals from the S.T.A.R. Foundation of Monterey County stewardship fund. Dan used this as an example to demonstrate the value of stewardship funds.

Motion: To approve the withdrawal of \$500,000 from the S.T.A.R. Foundation of Monterey County stewardship fund.

Larry Oda / Judy Guzman Krueger second. Motion carried unanimously.

PHILANTHROPIC SERVICES – Christine Dawson for Betsey Pearson

Senior Vice President Philanthropic Services Christine Dawson presented the Resource Development Report. She highlighted several past and upcoming events. It was noted that engaging again with donors and financial advisors has been energizing.

Senior Vice President Dawson explained Charitable Gift Annuities to the board as they need board approval. She presented the new Robert Haas Charitable Gift Annuity for approval.

Finance Committee Minutes August 23, 2022

The meeting of the Finance Committee of the Community Foundation for Monterey County was called to order by Jan Vanderbilt at 2:03 p.m. The meeting was conducted via Zoom.

Action Items

Minutes

Jan called for a motion to approve the June 28th meeting minutes.

Motion: Joe Pezzini made a motion to accept the meeting minutes, with a second from Kirk Gafill. The motion passed unanimously.

Financial Statement Review

The June 2022 and July 2022 financial statements were presented, reviewed, and discussed in detail.

It was pointed out that the total assets listed on the notes section of the financial statements is \$355MM but the statement of position section indicates \$335MM. Kim confirmed that the correct number is \$335MM and will update the financials accordingly.

Motion: Jan Vanderbilt made a motion to approve the financial statements as of July 31, 2022, and June 30, 2022, with the correction to total assets in the notes section reflected as \$335MM. Kirk Gafill seconded the motion. The motion passed unanimously.

Discussion Items

Budget Discussion and Timeline

Kim laid out the general timeline for the budget preparation. Round one of the budget worksheets will be provided to department heads on August 24th. Department heads will have two weeks to submit back to Kim. Dan and Kim will then review and begin round two to review and modify the budget if necessary. Kim will provide a draft of the budget to Jan on October 1 for Jan's review. The budget draft will then be presented to the committee in the October meeting. There's an option for an additional special committee meeting for November if deemed necessary and a final budget will be presented to the Board in December.

Dan Baldwin opened the discussion with the committee on guidance of budgeting philosophy, specifically if the budget were to show a deficit. Given market performance for 2022 and the inflationary effects on staff compensation and benefits, CFMC may have a budget deficit for 2023 because personnel expenses make up the lion's share of the budget. Dan explained that over the last five years, CFMC experienced a budget surplus each year with a total accumulation of about \$2.5MM. The committee discussed the importance of prioritizing a long-term, forward-thinking approach for budgeting versus a short-term approach to obtain a balanced budget. It was highlighted that CFMC could utilize the accumulated budget surplus from prior years to support a budget deficit.

The committee decided that it would be helpful to thoroughly review and understand the assumptions that make up the budget if it were to show a deficit during the budgeting process rather than viewing the budget in near final form. This way the committee could discuss whether to question or support the organizational priorities and why the budget would be a deficit when it is presented to the board. Dan acknowledged that the plan will be to openly communicate with the committee, then decide whether there should be a special meeting to review the budget in the middle stages of budget development.

Operating Reserve Policy

Dan presented the draft of the updated Operating Reserve Policy. The notable changes included that months cash on hand is recommended to be updated to 4-8 months instead of 3-6 months. Additionally, language was added to include guidance for the committee to address the excess cash if the months of cash on hand exceeds eight months. Approving these changes would require the committee to review, discuss, and make a recommendation on the excess or insufficient months of cash on hand when it's presented twice a year. This review will be a standing agenda item for February and August committee meetings.

Motion: Jan Vanderbilt made a motion to approve the changes to the Operating Reserve Policy that were presented. Kirk Gafill seconded the motion. The motion passed unanimously.

<u>Assets</u>

Total Assets through 8/31/2022 are \$327,282,281 a 12.33% decrease since August 2021 and a 15.36% decrease since December 2021. (p. 4)

Charitable Remainder Trusts (CRT) and Charitable Gift Annuities (CGA)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2021. In August, Robert Haas established his 11th CGA with \$65,000 cash. The \$30,705.25 calculated remainder value is designated for the Operating Fund. **(p. 4)**

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized losses were \$5,864 and unrealized losses were \$49,220,613, for a total loss of \$49,226,477. (p. 7)

Operating Fund

Total revenue was \$124,174 more than the budget, and total expenses were \$208,837 less than the budget. Unrealized losses were \$94,592 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$611,488 compared to a budgeted deficit of \$849,677. (p. 8)

Revenue continues to be higher than budget through August. However, projections for the third quarter administrative fees based on the June 30 fund balance reflect fees lower than budgeted resulting in a one-half (.5) month decrease in cash on hand over the next three months.

Salaries and benefits continue to be below budgeted amounts. This savings is the result of position vacancies in the first quarter that have now been filled, as well as just over a month of savings on the recent Director of Gift Planning vacancy. That position has now been filled. While the salary increases related to the Croner salary study were approved as a budget amendment, additional unbudgeted salary increases will diminish the salary savings over time. In addition, the renewal of the medical insurance, effective September 1, 2022, was higher than the budgeted expected increase. However, savings through September related to staff members declining budgeted coverage will offset the higher cost in the fourth quarter. Overall, salaries and benefits are expected to remain under budget through the end of year.

Overall administrative expenses continue to be below budget. However, higher than budgeted bank charges due to fees assessed on large credit card donations and contracted services for high level accounting assistance during the Director of Finance recruitment have resulted in overages in bank fees and services.

The 2022 rental agreement for the Salinas property was revised in late 2021. The agreement revised the rent structure to include a utility allocation. As this was completed after the budget process, there is a variance (under) on rent that is offset by a variance (over) on utilities as the agreement shifted the expense classification. This will continue through the end of year and be corrected in the 2023 budget.

Unexpected increases in printing, postage, and design services resulted in a budget overage for production of the annual report. The printing service was \$10,057 over budget due to paper and supply chain issues. The annual meetings expense currently reflects a budget deficit; however, this is related to the timing of payments for the Celebration of Philanthropy and will correct in future months. New hires and other staff life events have resulted in an overage on staff recognition expense. This overage will run through to year end. Overall, Development, Program & Staff is reflecting expenditures that are \$1,045 over budget. Staff is monitoring expenditures for potential areas of savings in the category; however, resumption of events is anticipated to limit the ability to offset the overall budget overage.

Note: The Expendable Operating Cash-on-Hand is at 8.0 months, excluding the operating reserve of \$500,000 and the building reserve of \$150,000.

Portfolio Performance

The market value of the Long-Term Fund portfolio at 8/31/2022 was \$266,814,411. The one-year Total Return for the Long-Term Endowment Portfolio was -13.0% compared to the Policy Index of -10.7%.

The market value of the Medium-Term Fund portfolio at 8/31/2022 was \$9,699,847. The one-year Total Return for the Medium-Term Endowment Portfolio was -13.1% compared to the Policy Index of -11.9%.

The market value of the ESG Fund portfolio at 8/31/2022 was \$6,948,739. The one-year Total Return for the ESG Portfolio was -12.2% compared to the Policy Index of -13.8%.

The market value of the DRIM Fund portfolio at 8/31/2022 was \$2,806,906. At 7/31/22, the one-year Total Return for the DRIM Portfolio was -10.9% compared to the Policy Index of -4.8%. Due to the timing of the DRIM reports, there is a one-month lag in the performance reporting.

Special Program Funds

Special Program Funds include Center for Nonprofit Excellence funded by the David and Lucile Packard Foundation; the Salinas Inclusive Economic Development Initiative, funded by the James Irvine Foundation; COVID-19 Collaborative support funded by the David and Lucile Packard Foundation; COVID-19 support funded by the Public Health Institute; and the Monterey County Gives annual campaign.

Total Special Program revenue was \$1,686,058 and total expenses were \$12,872,247. This includes grant expense of \$9,493,617 for the 2021 Monterey County Gives campaign. (p. 6-7)

The CRT and CGA funds have been adjusted to reflect the activity and balances per Kaspick & Company and the third-party account balances as of December 31, 2021. (p. 4)

Realized and Unrealized Gains and Losses on Investments

Net year-to-date realized gains were \$401,712 and unrealized losses were \$71,834,239, for a total loss of \$71,432,527. (p. 7)

Operating Fund

Total revenue was \$65,832 less than the budget, and total expenses were \$190,521 below budget. Unrealized losses were \$130,424 on the operating reserve held in the Medium-Term Fund portfolio. The actual net operating deficit is \$281,589 compared to a budgeted deficit of \$275,596. (p. 8)

Revenue dropped below budgeted amounts in September. Projections for the fourth quarter administrative fees based on the September 30 fund balance reflect fees lower than budgeted. However, staff efforts to find cost savings is expected to keep the cash on hand stable through year-end.

Salaries and benefits continue to be below budgeted amounts due to vacant positions throughout the year. CFMC is now fully staffed and, while the salary increases related to the Croner salary study were approved as a budget amendment, additional unbudgeted salary increases will erode the salary savings over time. In addition, the renewal of the medical insurance, effective September 1, 2022, was higher than the budgeted expected increase. Savings through September related to staff members declining budgeted coverage will offset the higher cost in the fourth quarter. Overall, salaries and benefits are expected to remain slightly under budget through the end of year.

Overall administrative expenses continue to be below budget due to cost savings on systems maintenance costs and anticipated conferences that continued to be held virtually. However, higher than budgeted bank charges due to fees assessed on large credit card donations contracted services for high level accounting assistance during the Director of Finance recruitment have resulted in overages in bank fees and services.

The 2022 rental agreement for the Salinas property was revised in late 2021. The agreement revised the rent structure to include a utility allocation. As this was completed after the budget process, there is a variance (under) on rent that is partially offset by a variance (over) on utilities as the agreement shifted the expense classification. This will continue through the end of year and be corrected in the 2023 budget.


