CALL TO ORDER

Board chair Rick Kennifer called the regular meeting of the Board of Directors of the Community Foundation for Monterey County to order at 3:42 PM, Tuesday, February 24, 2015 at the Foundation's Monterey Office. Rick welcomed Jimmy Panetta and Erica Padilla-Chavez to their first official board meeting.

Rick Kennifer asked the board if they had any questions or required clarification on matters related to the consent agenda. There were no questions or concerns.

REPORT OF THE CHAIR – Rick Kennifer

Rick Kennifer highlighted the successful Legacy Society Luncheon, which occurred earlier in the day at the Monterey Plaza Hotel. Over 160 attended. Rick thanked the CFMC board members that attended, CFMC staff, Dan Baldwin and guest speaker Michael Reid, who spoke on behalf of the Fund for Homeless Women.

Rick reported the revised meeting schedule for the 2015 board meetings includes June 23 and October 27 meetings that will be held in the Salinas office.

TREASURER / FINANCE COMMITTEE—Tina Starkey Lopez December 31, 2014

Assets

Total Assets through 12/31/2014 are \$179,317,002 a 2.73% increase since December 2013.

Operating Fund

Total revenue was \$214,165 more than the budget, and total expenses were \$69,019 more than the budget. The actual net operating surplus is \$159,490 compared to a budgeted surplus of \$14,344.

Note: The Expendable Operating Cash-on-Hand is at 6.5 months, excluding the operating reserve of \$250,000 and the building reserve of \$100,000.

Gifts, Pledges, Bequests, Future Funds Greater than \$25,000, and Grants

Total new contributions for the month were \$2,557,263 including \$150,000 from the Howard and Anne Morgens Foundation for the Howard and Anne Morgens Fund, \$50,000 from Community Human Services for the Community Human Services Stewardship Fund, stock valued at \$99,447 from Peter and Jackie Henning for the Peter and Jackie Henning Fund, stock valued at \$40,174 from Mr. & Mrs. Tom and Julie Anne Hopkins for the Youth in Wilderness Fund and the MC Gives campaign, \$75,000 from the Church in the Forest to establish the Church in the Forest Stewardship Fund, \$31,000 from Mr. & Mrs. William H. and Susanne Tyler, III for the William and Susanne Tyler Fund, \$250,000 from Mr. Scott Corwon for the Scott Corwon Fund, \$50,000 from Mr. & Mrs. Michel and Mary Orradre for the Mike and Mary Orradre Fund, \$90,000 from Mr. F. Robert Nunes for the F. Robert Nunes Family Fund, \$50,000 from Carmel Realty Brokerage Services to establish the Carmel Realty Foundation, \$87,500 from The Alexander F. Victor Foundation to establish The Alexander F. Victor Foundation Fund, \$60,000 from The Nepenthe/Phoenix Corporation Community Investment Program for the Nepenthe/Phoenix Corporation Fund, \$38,067 total proceeds from the Bubbles & Bags event for the Girl's Health in Girl's Hands activities of the Women's Fund, and \$849,582 combined gifts from individuals for the MC Gives campaign.

Grants to agencies for the month totaling \$2,208,785 were approved and recorded.

Interfund activity for the month totaled \$200,250.

Bequests Receivable

We recorded bequest receivables in the amount of \$50,000 from Mr. John Love and \$225,000 from Mrs. Nancy Maytag Love, when received; the proceeds will be added to The John and Nancy Love Fund.

Motion: to approve the December 31, 2014 Financials Gail Delorey / Tina Lopez. Motion carried unanimously.

January 31, 2015 Financials

Assets

Total Assets through 1/31/2015 are \$178,741,106 a 4.14% increase since January 2014, and a .32% decrease since December 2014.

Operating Fund

Total revenue was \$56 more than the budget, and total expenses were \$6,952 less than the budget. The actual net operating deficit is \$245,548 compared to a budgeted deficit of \$252,558. Note: The Expendable Operating Cash-on-Hand is at 5.0 months, excluding the operating reserve of \$250,000 and the building reserve of \$125,000.

Gifts, Pledges, Bequests, Future Funds Greater than \$25,000, and Grants

Total new contributions for the month were \$286,762 including stock valued at \$106,179 from Mr. & Mrs. William and Nancy Doolittle for the Doolittle Fund.

Grants to agencies for the month totaling \$150,000 were approved and recorded. A complete list of the grants by grantee is included.

Interfund activity for the month totaled \$9,000.

Contributions Receivable

We received the second of three payments, in the amount of \$459,332, from the David and Lucile Packard Foundation for the Community Leadership Project.

Motion: to approve the January 31, 2015 Financials.

Gail Delorey \ Greg Chilton second. Motion carried unanimously.

INVESTMENT COMMITTEE – Dan Baldwin for Ken Petersen

Dan Baldwin reviewed the Pooled Endowment Portfolio Overview for the period ending 12/31/14. Dan described the current asset allocation and reported the YTD returns were 4.0% compared to the policy benchmark of 5.1%

Dan reported the Investment Committee discussed the idea of having a lower risk portfolio option for the benefit of interested donors and agencies. As well as, continued research on ways to make sure the investment policy statement and our stated return objectives are working together and are consistent with one another.

GRANTS AND PROGRAMS - Alfred Diaz-Infante

Alfred Diaz-Infante reported in the spring Community Impact (CI) applications are considered for the Investing in Our People program area. This spring, 95 grant applications were received. 26 "small" applications (requesting \$12,000 or less), 52 for Youth Development & Education (formerly Building Blocks), 42 for Health & Human Service (formerly Wellness) and one ineligible (Arts); total requested: \$2,353,834.

Motions 1: To approve the December 1, 2014 to January 31, 2015 grants (217) totaling \$2.566.035.

Alfred Diaz-Infante / John Phillips second. Motion carried unanimously.

Motion 2: To approve the grants over \$50,000 – totaling \$575,000. \$250,000 to the National Aquarium from the Scott Corwon Fund, \$225,000 to the ACTION Council from the Women's Fund Endowment, \$50,000 to Shelter Outreach Plus from the Fund for Homeless Women Non-Endowed Fund and \$50,000 to the Monterey Bay Aquarium from the Landreth Family Fund. Gail Delorey noted the grant to Shelter Outreach Plus for \$50,000 had been approved at the December 16 board meeting.

Alfred Diaz-Infante / John Phillips second. Motion carried unanimously.

NEW FUNDS APPROVED SINCE LAST MEETING: Dan Baldwin

Dan reported the Monterey Bay Economic Partnership (MBEP) Stewardship Fund is waiting for the designation letter for 501©3 non-profit status before the fund is active.

NEW FUND APPROVALS - Dan Baldwin

Action item: The Mathew Paul Finnegan Memorial Scholarship Fund

A correction to the October 24, 2014 minutes should read, "a non-endowed donor advised (DA) fund to an endowed scholarship fund".

Motion: to approve the correction to The Mathew Paul Finnegan Memorial Scholarship Fund from a non-endowed donor advised fund to an endowed scholarship fund.

Greg Chilton / Erica Padilla-Chavez second. Motion carried unanimously.

RESOURCE DEVELOPMENT- Greg Chilton

Greg Chilton reported on the December 2014 and January 2015 Resource Development Summaries. He highlighted the 2015 expectancies and recognized the value of professional advisors to refer the CFMC to their clients.

The Women's Fund Luncheon will be April 30, 2015 at the Hyatt Hotel. The goal will be to wrap up the \$1.5M endowment campaign and celebrate the fund's 10-year anniversary.

AUDIT COMMITTEE – Dan Baldwin for Ken Wright

The Audit Committee met with Tom Rockwell, senior partner, from PMB Helin Donovan to discuss the timeline for the 2014 audit.

The committee recognizes the volume and diversity of non-traditional gifts is growing and the audit is getting more complex. The committee will assess whether an RFP is needed to search for a new audit firm in 2016.

PRESIDENTS REPORT - Dan Baldwin

Dan reported the sale of Palm Terrace in Hawaii is progressing with a solid offer, but still requires the approval of the Queen's Trust. He summarized the history of the asset and sale of the property for the board.

Dan reviewed all the 2014 non-traditional assets held by the CFMC.

Dan and Rick led a discussion about the results from the Monitor Institute exercise at the board retreat. There was discussion about next steps toward updating the 2010 strategic plan based on some of the aspirations discovered through that exercise. The strategic plan update will be on the agenda of the March 24, 2015 Executive Committee meeting, who will bring a recommendation to the April board meeting. A summary of the timeline for the previous strategic plan process and the need for a facilitator to assist the board with the strategic plan update will be presented.

The board went into Executive Session.

Call to Order - Rick Kennifer

Rick Kennifer called the regular meeting of the Executive Committee of the Community Foundation for Monterey County to order at 3:35 PM, Tuesday, March 31, 2015, at the Foundation's Salinas office.

Approval of Minutes

There was one correction to the November 25, 2014 Executive Committee meeting minutes. Greg Chilton noted on page 2 of the minutes, the Action item not on the agenda should read Certificate of Deposit not Certificate of Liability.

"The Finance Committee is requesting the approval of a resolution to purchase three Certificates of Liability Deposit from Rabobank." (Corrected language 3/2015 JC)

Motion: to approve the November 25, 2014 minutes: Greg Chilton / Alfred Diaz-Infante second. Motion carried unanimously.

Chair Report - Rick Kennifer

Rick Kennifer noted the Women's Fund Luncheon is April 30, 2015 starting at 11:30 AM at the Hyatt Hotel in Monterey. The Women's Fund is celebrating 10 years and will highlight new initiatives and close the \$1.5 million endowment campaign.

The Council on Foundations conference is April 26-28 in San Francisco. Three board members and five staff members will attend. Dan Baldwin will facilitate a session on Endowment Building.

Rick reported the board will be asked at the April 21 board meeting to pass a resolution for 100% board contributions for 2015. It is a requirement for a pending grant application.

Treasurer's Report -Tina Starkey Lopez February 28, 2015

Assets

Total Assets through 2/28/2015 are \$181,212,789 a 3.37% increase since February 2014, and a 1.06% increase since December 2014.

Operating Fund

Total revenue was \$3,464 more than the budget, and total expenses were \$28,525 less than the budget. The actual net operating deficit is \$428,231 compared to a budgeted deficit of \$460,219.

Note: The Expendable Operating Cash-on-Hand is at 4.6 months, excluding the operating reserve of \$250,000 and the building reserve of \$125,000.

Gifts, Pledges, Bequests, Future Funds Greater than \$25,000, and Grants

Total new contributions for the month were \$898,990 including stock valued at \$78,957 from Mr. & Mrs. William and Nancy Doolittle for the Doolittle Fund; \$650,000 for The David and Lucile Packard Foundation for The David and Lucile Packard Foundation Fund; \$95,000 from S.T.A.R. Foundation of Monterey County for the S.T.A.R. Foundation of Monterey County Stewardship Fund; and \$30,000 from Mr. & Mrs. Richard S. and Joanna Reynolds for the Richard Scott Reynolds Science and Technology Education Scholarship Fund.

Grants to agencies for the month totaling \$1,508,920 were approved and recorded.

Interfund activity for the month totaled \$13,500.

Motion: to approve the February 28, 2015 financials. Tina Starkey Lopez/Steve McGowan Motion carried unanimously.

Tina summarized the 2014 audit process and commended Diane Nonella for another clean audit with no remarks. The auditors reported the internal controls were effective and required no additional processes.

Tina reported the finance committee goals for 2015 are to support CFMC to hire an Accounting Manager, to provide direction for fiscal responsibility and long-term financial needs.

Grants and Programs Committee - Alfred Diaz-Infante

Alfred Diaz-Infante reported there was one grant approval request. The CFMC Grants and Programs staff are requesting the approval of the proposed fund allocations for 2015 grants from the Futer Fund for Human and Humane Needs.

- \$227,942 from the Rudy E. Futer Fund for Human & Humane Needs to the Rudolph E. Futer Restricted Purpose Fund, for designated agency grants and administrative fees.
 - Rudolph E. Futer Restricted Purpose Fund designated agencies:
 - o \$56,985.50 to CARE U.S.A. San Francisco Region
 - o \$56,985.50 to Child Family Health International
 - o \$56,985.50 to Lifewater International
 - o \$56,985.50 to Humane Society of the United States

Motion: to approve \$227,942 from the Rudy E. Futer Fund for Human & Humane Needs to the Rudolph E. Futer Restricted Purpose Fund for four designated agency grants of \$56,985.50 each to: CARE U.S.A. - San Francisco Region, Child Family Health International, Lifewater International and Humane Society of the United States.

Greg Chilton/Alfred Diaz-Infante second. Motion carried unanimously.

Grant approval not on the agenda: Willemsen Family Fund grant for the reading specialist and /or teaching staff salaries at Sacajawea Elementary School, Seattle Washington.

Motion: to approve \$56,000 to the Sacajawea Elementary School, Seattle Washington from the Willemsen Family Fund. Greg Chilton / Alfred Diaz- Infante second. Motion carried unanimously.

Alfred reported the Grants and Program goals for 2015 are:

- Advance Community Impact grantmaking toward strategic results
- Expand Women's Fund economic security grantmaking and leadership
- Expand role of CNE in supporting community leadership and nonprofit effectiveness
- Continue expansion of activities in Salinas Valley/South County
- Increase Grants and Programs alignment with CFMC philanthropic services to expand services to donor advisors, private foundations and corporations and scholarship programs
- Assert CFMC leadership role in convening community around key issues

Investment Committee - Ken Petersen

Ken Petersen reported the Investment Committee continues to review the investment portfolio and analyze the spend rate for the long term. The committee and Wurts & Associates are evaluating the Foundations return objective and the portfolios prospective 10 year returns.

The Investment Committee's on-going goals are:

- Asset allocation and risk analysis
- Monitoring investment objectives, policies and procedures
- Evaluate the practices and performance, allocations, return goals and fees

The committee would like to determine whether a lower risk fund is a viable option for short-term stewardship and certain donor advised funds.

Governance Committee – Dan Baldwin for Gail Delorey (absent)

Dan Baldwin reported he will connect with Gail Delorey after the tax season.

Resource Development Committee - Greg Chilton

Greg Chilton reviewed the February Resource Development Summary and highlighted the Southern Monterey County Foundation at the fairgrounds in King City. Over 100 people attended the event. Christine Dawson reported that over \$75,000 has been generated by the "Founding Family" campaign where donors are asked to contribute \$1000 a year for five years or \$5000 now. Half of the money goes to the endowment and half to the non-endowed fund.

Greg Chilton summarized the Resource Development 2015 goals:

- Develop philanthropic services standards
- Create Salinas Valley affiliate fund
- Latino philanthropy
- Develop a professional advisor council
- Revise Gift Acceptance Policy
- Increase scholarship funds
- Expand Legacy Society
- Update fund agreements

Dan described three new agency stewardship funds: The Morse Foundation Stewardship Fund, YWCA and Peace of Mind Rescue.

Greg Chilton / Steve McGowan second. Motion carried unanimously.

Motion to approve: The Dekker Davidson Foundation a non-endowed, donor advised fund. Steve McGowan / Ken Petersen second. Motion carried unanimously.

President/CEO Report - Dan Baldwin

Dan reported the sale of the Palm Terrace property in Hawaii is not moving forward with the current buyers, but there is a new prospect.

Rick Kennifer opened a discussion about the CFMC strategic plan. There was a lively conversation about impact investments, community leadership and the direction the CFMC might consider for the future. Alfred brought up the difference between a facilitator and a consultant for the process and felt having a facilitator was very beneficial. The Executive Committee reached a decision to bring the question of how to proceed to the full board at the April 21 meeting. Rick will recommend the use of a facilitator and a ½ day special meeting to update the CFMC strategic plan.

The meeting of the Audit Committee of the Community Foundation for Monterey County began at 9:25AM on April 13, 2015; there was not a quorum.

BBR Presentation

Molly reviewed the financial statements, noting significant changes from prior years, including:

- Significant increase in contributions due to the Duff and Dawson estates
- Expenses increased mostly due to an increase in grantmaking activity
- Permanently Restricted Net Assets decreased due to the conversion of endowed donor advised funds to non-endowed donor advised funds

Dan Baldwin commented that the fund conversions had a significant impact on the increased grantmaking.

Diane Nonella made a correction to Note 14 – Retirement Plans, to correct the eligibility period from after one-year, to immediately eligible, with a six-month vesting period.

Discussion Item

Dan Baldwin discussed the description for the TAP CommodityBuilder Fund, which is described as a hedge fund, and recorded as a Level 3 holding, but is described by Wurts as a Level 2, alternative investment.

Tom Rockwell and Molly Goshorn will contact Anne Westreich at Wurts to discuss and clarify how the holding should be recorded.

Having no further business, staff was excused and the committee went into executive session.

The meeting of the Investment Committee of the Community Foundation for Monterey County was called to order by Ken Petersen at 3:04PM on February 2, 2015.

Ken Petersen welcomed new committee member Jimmy Panetta.

Wurts & Associates

Anne Westreich reviewed the fourth quarter 2014 results. The market value of the portfolio at 12/31/2014 was \$144,398,309. The YTD returns were 4.0% compared to the policy benchmark of 5.1%.

Anne also reviewed the Active Management Environment report, the 2014 look back, and the 2015 work plan.

Anne reviewed the benchmark comparison report, and the committee discussed the benchmarks used. Bill Sharpe suggested, and Ken Petersen agreed, we should change the benchmark for alternative holdings from CPI+5% to something that is investable. Anne will research other benchmark options, and report her findings at the May meeting.

Stephen Dart commented a dichotomy exists between how we construct our endowment portfolio and our stated return objective.

Our Investment Policy Statement (IPS) governs our endowment and determines and monitors our asset allocation and manager selection. The IPS reflects modern portfolio theory and is mindful of the importance of diversification and risk management.

Our Stated Return Objective (SRO) is determined by summing our current spending policy (4.5%), anticipated inflation rate (2.4%) and approximate administrative costs (1.0%) that equal 7.9%.

The dichotomy occurs because the IPS and SRO are arrived at independently of one another. This needs to change in order to insure that our IPS and SRO are harmonized and the resulting allocation and objectives are consistent with one another.

There is only one (material) variable in either of the IPS or SRO over which we have any control: the current spending policy.

Given that our investment consultant projects that our anticipated 10 year growth forecast is < 7%, one of two things needs to happen. One, if we maintain an SRO of 4.5% then our asset allocation must be modified to target higher returns (which entails greater risk). Or two, if we are to be governed by our current IPS then our spending policy must be reduced accordingly.

The committee discussed Stephen's observations, and agreed further discussion will be included in the agenda for the February board meeting.

Discussion Items

Ken Petersen introduced the idea of adding a lower risk portfolio option, for the benefit of interested donors and agencies.

Dan Baldwin explained that many other community foundations have multiple investment options, and that he has received inquiries from local nonprofit agencies interested in this type of investment option, including one agency with approximately \$5 million to invest.

Dan further explained that this option would be available for new donor advised funds, new agency funds, and that we would not move funds from our current portfolio, unless requested by current donor advisors.

Dan will send the committee links to other community foundations with multiple investment portfolio options.

Anne will prepare scenarios for a low risk portfolio, and present them at the May meeting.

The low risk portfolio discussion will be included in the agenda for the February board meeting.

GRANTS AND PROGRAMS REPORT

Laurel Lee-Alexander, Vice President of Grants and Programs April 21, 2015 Board Meeting

ACTION ITEMS:

1. Approve Grant Awards, February -- March. Between February 1 and March 31, 2015 the Community Foundation awarded 314 grants totaling \$2,885,563. (See list of grants since the last board meeting.)

INFORMATION ITEMS:

1. Community Impact Grants Program:

Community Impact (CI) grant application review is underway. The spring grantmaking
cycle is going well, receiving overall positive feedback regarding our new online grant
system from applicants and committee members. Staff continues to request constructive
feedback from all users to improve the process and experience.
Applicants' comments include.

I feel the application process was very easy to understand. I appreciate that some sections had examples of the type of "concise" information CFMC was looking for and helped guide the application.

I really liked it. Good clear questions with examples. Easy to use. Like the limited space. Uploads were very easy. Thanks.

Committee members' comments include,

I really liked the new online application – what a difference in my ability to read each proposal more thoroughly and evaluate them against the criteria – and one another.

I am a paper person and I liked the old system. But I have to say that reviewing the grant applications online was not only easy but more efficient.

• Information sessions will be provided this summer in preparation for the August application deadline. The focus of these sessions is to help prospective applicants understand how to use our online grant system.

2. Center for Nonprofit Excellence (CNE):

- The 2015 LEAD Institute participants have identified personal, professional development and organizational change goals, and attended the first three monthly seminars on nonprofit management and leadership topics.
 - In response to requests from the community, CNE has expanded its offerings for existing nonprofit leaders. Two learning circles for Executive Directors are underway, and a new four-part roundtable for board officers has begun with over twenty participants.

- CNE is leading an effort by the Capacity Builder's Network to provide multiple learning
 opportunities regarding evaluation, entitled "The Year of Impact". So far, CNE has
 helped bring the Packard Foundation's Kathy Reich for a luncheon presentation and
 sponsored a two-part workshop on Developing Vision statements.
- CNE hosted a six-part webinar series on Understanding Financial Statement, allowing
 participants to view it together and ask additional questions of the presenters. A two-part
 series on collaboration is underway.
- The Futer Essential Social Services grantees are working together to identify ways to share their successes and build greater community/fundraising support. CNE has facilitated several meetings with communications/marketing consultants to support this effort.
- Community Leadership Project (CLP) grantees attended their first peer convening of 2015, and many are participating in a two-part workshop on individual donor development.
- In its role as a member of NAMC's coordinating body, CNE staff helped present a legislative update and an information session on the recent report about the impact of nonprofits in the Monterey County economy.

3. Neighborhood Grants Program (NGP):

- The grants committee for the Neighborhood Grants Committee held their Applicant Assemblies on Saturday, April 11th in Salinas and April 18th in Greenfield to hear 19 of the 41 proposals received. The grants committee is scheduled to make their final recommendation on Friday, May 8th.
- The 2015 Neighborhood Grants Program Awards Ceremony is scheduled for Saturday, July 25th from 10:00 am to 12:00 noon at Hartnell Community College.
- The Neighborhood Grants Program and the Center for Nonprofit Excellence is coordinating a workshop for grassroots and small NPOs on how to develop an annual budget (income and expenses) to be held on Thursday, May 28th in the CFMC Conference Room in Salinas.

4. Girls' Health in Girls' Hands (GHGH):

- The Girls' Leadership Network (GLN), consisting of 12 girls who represent all-member agencies, facilitated an action-advocacy campaign to raise awareness on the need to prioritize social and emotional health, which was defined at the fall 2014 GHGH Summit by girls across the county as the top priority for youth health countywide. The campaign coordinated a youth-led petition at over 18 school and community sites countywide collecting 587 signatures from youth, educators, teachers, parents, administrators and public policymakers. The GLN also drafted a Resolution which was adopted by the Board of Supervisors in March 2015, recognizing the work of GHGH and the need to prioritize social and emotional health.
- GLN members and GHGH plan to meet with the Monterey County Board of Education and the Monterey County Health Commission in the coming months to present GHGH research and propose some youth-informed solutions to social and emotional health. Some of these solutions include; addressing the lack of access to counselors and schools staff trained to adequately support the social and emotional health of their students at schools, and asking for an allocation of funds for this training and increased access to counselors.
- Transition timeline for administrative and backbone support of GHGH to the Health Department is expected for summer 2015. Community Foundation will continue to stay involved with the initiative as a fiscal sponsor and advisor and will work closely with

Rose Vasquez, Health Program Coordinator and the Hub of GHGH to ensure a successful transition and long term sustainability of GHGH.

5. Community Leadership Project (CLP):

The CFMC has been invited to apply for funding for the final phase of CLP 2 (through July 2017), which will provide the community grantees with "exit year" grants and continued capacity building support. A convening of all 13 Central Coast community grantees and the three community foundations was held at the National Steinbeck Center on April 2.

6. Community Leadership and Partnerships

- a) Research and planning continues for two community issues:
 - Homelessness
 - The President/CEO and VPGP have met with numerous leaders of local homeless services organizations to gather information and ask how the CFMC can help raise awareness and help the agencies lead their efforts to address the issues.
 - We have scheduled a community meeting on Wednesday, May 27 (3:00 5:00 pm, CFMC Monterey) to continue the discussion and offer our assistance.
 - Youth Programs/Violence Prevention
 The President/CEO and VPGP are meeting with local experts to learn more about the issues and potential gaps in service.
- b) The Packard Foundation is hosting a discussion on April 23 about the principles and practices of strategic restructuring, including nonprofit mergers, joint ventures, and partnerships featuring LaPiana Consulting. Partners include the CFMC, Community Foundation Santa Cruz County, and Monterey Peninsula Foundation.

<u>Assets</u>

Total Assets through 3/31/2015 are \$180,822,203 a 2.74% increase since March 2014, and a .84% increase since December 2014.

Operating Fund

Total revenue was \$16,874 less than the budget, and total expenses were \$30,536 less than the budget. The actual net operating surplus is \$1,675 compared to a budgeted deficit of \$11,986.

Note: The Expendable Operating Cash-on-Hand is at 6.4 months, excluding the operating reserve of \$250,000 and the building reserve of \$125,000.

Gifts, Pledges, Bequests, Future Funds Greater than \$25,000, and Grants

Total new contributions for the month were \$1,415,003 including \$1,129,480 from the Central Coast Veterans Cemetery Foundation for the Central Coast Veterans Cemetery Foundation Fund; \$100,000 from Girls, Inc. of the Central Coast to establish the Girls, Inc. Stewardship Fund; \$50,000 from Peace of Mind Dog Rescue to establish the Peace of Mind Dog Rescue Stewardship Fund; and \$50,000 from the YWCA Monterey County to establish the YWCA Monterey County Stewardship Fund.

Grants to agencies for the month totaling \$1,121,197 were approved and recorded.

Interfund activity for the month totaled \$40,190.

The CFMC still seeks to evolve itshave a grant making program to one that, while still broad enough to address Monterey County's most pressing needs, has greater focus; and resulting results in tangible and demonstrable impact. All grant programs should seek to align with This program should be developed within an overarching framework that defines CFMC's programmatic purpose as "investing in healthy, safe and vibrant communities across Monterey County"—a unifying theme that also encompasses CFMC's plan to intentionally exercise its community leadership role. Goal one will be driven by the following three statements.

- 1. Proactively be a partner and catalyst for addressing community challenges.
- 2. Focus grant making toward strategic results.
- 3. Strengthen nonprofit sector excellence.

Goal Two: Philanthropic Leadership Inspire and facilitate philanthropy throughout Monterey County.

The Community Foundation for Monterey County has a strong asset base, and an enviable percentage of endowed and/or discretionary assets. The CFMC's commitment to building endowment funds, primarily through planned gifts, has never waned. However, if so desired, more emphasis can be placed on building discretionary assets (unrestricted/field of interest). The gift life cycle of creating these funds through estate planning is very long and requires tremendous patience. The CFMC's commitment to stronger relationships with donor advisors is producing remarkable results. We must now build on our successes. Not only must we continue to adhere to a resource development plan that actively engages and updates the professional advisor community, but we must continue to offer philanthropic value to individuals, families, corporations and private foundations. -Diversity in Monterey County takes many forms. Geography, Ethnic. Gender. Even philanthropic interests. The CFMC must be creative in being developing relationships in all our communities. In its next chapter, the Foundation seeks to form new philanthropic partnerships and further increase those assets in order to continue supporting a grant making program that is fully responsive to the many needs in Monterey County. Not only should grant making continue countywide, but so should the discovery of new philanthropic partners.
